JIT Timeline

- 26 May Initial Environmental Sub-committee Meeting regarding the Camp Carroll Agent Orange allegations. USFK provided to MOE the 1992 Historical Land Use and Background Survey and the 2004 Camp Carroll Area D and Area 41 Site Investigation.
- 1 June Environmental Subcommittee Meeting -- established the Joint Investigation Team.
- 13 June USFK provided MOE the May 2011 Groundwater Test Results for Phase I, II and IIB.
- 16 June JIT Press Conference to release the off-post water test results.
- 23 June JIT Press Conference to release 1992 Historical Land Use and Background Survey and the 2004 Camp Carroll Area D and Area 41 Site Investigation.
- 27 June Environmental Subcommittee Meeting -- presented and consulted on the PH I geophysical survey results.
- 8 July JIT Press Conference to release the results of the phase I geophysical survey and phase one soil test plan.
- 22 July JIT Meeting to discuss on-post water test results.
- 26 July Environmental Subcommittee Meeting to consult on phase II geophysical survey results and develop phase II Soil Sampling Plan.
- 27 July JIT meeting following the visit to Camp Carroll by Mr. House.
- 2 August USFK provided MOE with information regarding the disposition of the items discovered during the 2008 land farm expansion at Camp Carroll.
- 5 August JIT Press Conference to release results of on-post water tests, off post soll sampling and phase II geophysical survey.
- 9 September JIT Press Conference to release the results of the groundwater testing in Area 41 and the results of the soil sampling and geophysical survey conducted on the area identified by Mr. House during his visit to Camp Carroll as the location where he buried Agent Orange.
- 13 October Environmental Subcommittee Meeting to consult on the necessity of soil sampling in Area 41 and to determine the necessary steps required to conclude the investigation.
- 6 December Environmental experts of the JIT meet to consult on need for soil sampling in Area 41.
- 29 December Final JIT Press Conference to release results of water sampling in Area 41 and announce findings of the JIT an announce conclusion of the investigation.
