Veterans Education Benefits Information

VETERANS EDUCATION BENEFITS INFORMATION

To receive Veterans Education Benefits you must:

- Apply, be admitted to, and enroll at the University
- Apply to Veterans Affairs (VA) for benefits
- Notify the VA Certifying Official

ADMISSION

- 1. Complete an on-line application by logging onto www.csumentor.edu and submit required documents to the Admissions and Recruitment office.
- 2. Select a program of study (a requirement for VA benefits).
- 3. Contact Admissions and Recruitment for specific application documents required for admission decision (i.e., test scores, official transcripts).
- 4. Submit transcripts from the Army/American Council in Education Registry Transcript System (AARTS) or Sailor/Marine American Council on Education Registry Transcripts (SMARTS) for evaluation.
- 5. Submit a copy of DD-214 for possible course credit and additional benefits.
- 6. Submit necessary enrollment documents upon gaining admittance to the University.

Please note: Credit is granted for accredited, baccalaureate-level course work only. For additional information regarding the admission process, please contact Admissions and Recruitment at:

REGISTRATION

- 1. Only students who have been admitted may enroll.
- 2. Academic advisors will assist in planning your class schedule. Please visit the Advising Center in the Bell Tower or call (805) 437-8571 to schedule an appointment.
- 3. Notify the CSU Channel Islands Certifying Official that you have registered for classes.
- 4. Notify the CSU Channel Islands Certifying Official if you have a change in status such as dropping a course, withdrawing from a course, or changing your program of study.

Please note: Only courses within the student's program of study are eligible to count toward veterans benefits.

PROGRAM SELECTION

- 1. Veterans receiving VA benefits may select any program leading to a degree offered at California State University Channel Islands upon approval from Veterans Affairs. Veterans cannot receive benefits concurrently under two programs. If the veteran decides to major in two programs at the same time, only one will be certified.
- 2. Veterans may change a program of study and continue to receive benefits if the new program is approved by the VA. You must notify the CSU Channel Islands Certifying Official if you are planning to change your program of study.

APPLY FOR VETERANS EDUCATION BENEFITS

Only VA can determine eligibility. Please visit www.gibill.va.gov.

The following must be submitted for the certification process. It is the veteran's responsibility to assemble all required documents and submit them to the CSU Channel Islands Certifying Official.

Applicants Under Chapters 30, 33 & 35

- 1. New applicants complete VA Form 22-1990 or 22-5490 and submit online at www.gibill.va.gov. Please submit a copy of your application to the CSU Channel Islands Certifying Official.
- 2. Transfer students must complete VA Form 22-1995 or 22-5495 and submit a copy to the CSU Channel Islands Certifying Official.
- 3. Submit copies of DD214 Report of Separation, if applicable.

Applicants Under Chapter 31

- 1. New applicants complete the Disabled Veterans Application for Vocational Rehabilitation, VA Form 28-1900, and submit online at www.gibill.va.gov.
- 2. Your Vocational Rehabilitation Specialist will require an enrollment certification before classes begin.

Applicants Under Chapter 1606 (Reserves)

- 1. New applicants complete VA Form 22-1900.
- 2. Transfer students complete VA Form 22-1995.
- 3. Submit copy of DD2384 Notice of Basic Eligibility (NOBE)

PAYMENT

The first check should arrive SIX (6) TO EIGHT (8) WEEKS after the first day of class or later if the veteran should apply for certification after classes begin.

CERTIFICATION USING VETERANS STANDARDS OF PROGRESS

Veterans Affairs will not pay or will reduce pay of education benefits if one of the following should occur:

- 1. Student registers for classes that are not specified as necessary for the declared program of study. Depending on circumstances, deficiency or remedial courses may be certified for benefits.
- 2. Student fails to attend class for the semester for which VA benefits are received.
- 3. Student receives non-punitive grades at the end of the term, reducing training time.
- 4. Student remains in a probationary status for more than two consecutive terms or is academically disqualified.

ACADEMIC PROBATION AT CSU CHANNEL ISLANDS

An undergraduate student is subject to academic probation if at any time the cumulative grade point average (GPA) in all college work attempted or the cumulative GPA at CSU Channel Islands falls below 2.0. Students shall be removed from academic probation once they have received advising and both the cumulative GPA in all college work attempted and the cumulative GPA in all CSU Channel Islands work are at least 2.0 or higher.

ACADEMIC DISQUALIFICATION AT CSU CHANNEL ISLANDS

An undergraduate student on academic probation will be academically disqualified when the student's GPA in all units attempted or in all units attempted at CSU Channel Islands falls below the following:

Freshman: 1.50 Sophomore: 1.70 Junior: 1.85 Senior: 1.95 In order to be considered for reinstatement to CSU Channel Islands, a disqualified student must demonstrate academic ability by completing additional coursework.
