to charity watchdog Guidestar, and 14th among states in terms of the amount of money given to charities, according to the Catalogue for Philanthropy.

Officials in Florida know there are shortcomings in oversight.

"We do as we can. We just don't have the manpower," said consumer services Director J.R. Kelly, who has asked the Legislature to fund more positions.

"It's a big problem. Probably billions of dollars are donated by Floridians, and some portion of it is a rip-off. Just what percentage is anybody's guess," said Terence McElroy, a state consumer agency spokesman.

McElroy made that statement to another newspaper seven years ago.

Little has changed.

"In most cases people will never know they're being ripped off by a charity," McElroy said recently.

St. Petersburg resident Terry Richards has tried over the past few years to get local and state officials to crack down on suspicious veterans charities.


"I laid it out and nobody did a damn thing about it," Richards said. "I've pretty much just about given up in trying to get something done about these charities.

He isn't the only one complaining.

#### **Easy Target**

Florida, with its large senior citizen population, presents an attractive target.

A Tribune analysis of the 7,974 Florida-based charities registered with the state found thousands that use a high percentage of donations to help the needy. However, some do not. The analysis, using data received from the state in August, focused on those with yearly revenue of at least \$200,000.

The first list includes those that spend at least 75 percent of revenue on fundraising and administration. The second list is a sampling of those that limit fundraising and administration costs to less than 35 percent of revenue.

#### So-called veterans charity gives away only 8 percent of donations

OLDSMAR - On Veterans Day in a time of war, the sacrifices of a few are on the minds of many. Such sentiment for the troops could fill the coffers of charities like the Veterans Assistance Association, which actually concerns at least one veterans rights advocate.

"Right now, with the war being on, potential donors are going to be much more generous," observed Terry Richards.

The Veterans Assistance Association gave over \$12,000 to the cause last year, which sounds noble

until you examine the figures a little closer: last year, the charity took in \$167,517.

"Only 7.3 percent goes there. That kind of really upset me, and that's when I started writing people," Richards continued.

After hearing from Richards, Call for Action reporter Jackie Callaway went to the Veterans Assistance Association to find out why less than 8 percent of their proceeds actually goes to veterans.

Charity president Joel Markman blamed expenses.

"It's easy to be outraged, just looking at figures. But if you see the good we do for the community, it's a whole different story," he said.

To prove his point, Markman showed off dozens of letters the charity had received from veterans and their families, thanking the association for its generosity.

But that's still not good enough for some, like Murle Stubbins. He considers short-changing veterans a crime.

"The veterans deserve better. I'm not saying that because I am one," said Stubbins, who gave 46 years of his life to the Army, "but I know a lot of veterans who gave more than just time."



A month ago, Pinellas County consumer protection officials requested information from the Veterans Assistance Association, but the charity did not provide it. Now, their license has been suspended in Pinellas County, but they remain eligible to operate in Hillsborough County.

### Words of gratitude touch veterans

As Veterans Day approaches this Nov. 11, I hope that people everywhere in America will pay tribute to our nation's veterans, both living and dead.

There are approximately 26-million men and women veterans still alive in America. Only one out of every five men in America is a veteran. That's 20 percent ... yet, in men's homeless shelters nationwide, one out of three, or 33 percent, is a veteran. Of the estimated 750,000 homeless Americans, 250,000 are veterans.

From time to time I hear derogatory remarks from non-veterans about our nation's homeless veterans, Vietnam veterans or just veterans in general. Fortunately, the majority of Americans don't think this way.

When one enters the various VA hospitals and outpatient clinics nationwide, he will see tributes on the billboards, such as, "The price of freedom is visible here," or, "If you love your freedom, thank a veteran." However, none touches me as much as the tribute I found on the window at the agent cashier's office at the VA outpatient clinic in Columbus, Ohio. I would now like to share that tribute with all of you and hope that it touches you in the same way ...

"The veteran is the most important person in the hospital.

The veteran is not dependent upon us - we are dependent upon him.

The veteran is not an interruption in our work - he is the purpose of it.

The veteran is not an outsider to our business - he is our business.

> The veteran is a person and not a statistic. He has feelings, emotions, biases and wants ... It is our business to meet these needs.

The American veteran is God's gift to us ... Freedom is his gift to the world."

I am writing this letter on behalf of Mr. Terry Richards, a retired-disabled veteran who served honorably for our country in the U.S. Armed Services (1968-1970). I have known Terry for the past two years. I believe that I know him quite well. He is a regular attendee in a weekly support group that I run for veterans.

Terry is an independent Veteran's Advocate. He has considerable experience and expertise working largely in a volunteer capacity addressing issues affecting veterans. He has worked as a freelance journalist in media dealing with veterans issues. Terry possesses an encyclopedic fund of knowledge regarding access to health care and compensation issues affecting veterans. He has helped not only other members of our support group, but literally any veteran referred to him for help, without seeking any monetary compensation for his efforts. When faced with the daunting task of interacting with and navigating in search of services within a complex bureaucratic organization, such as the Veterans Affairs Health Care system, or the Social Security disability system, many veterans find themselves feeling helpless, intimidated, frustrated or demoralized. Through his expertise, patience, and personal commitment to helping veterans in need, Terry helps to demystify the process, and offers sound guidance which helps to restore a sense of hope, dignity, direction, and personal empowerment to the less fortunate.

Dear Mr. Richards:

Because of our strong mutual concern about efforts to use funding for veterans disability payments to offset transportation spending, I wanted to let you know of my recent efforts in this regard.

As you may know, on May 20th, the House, with my strong support, unanimously approved a motion to instruct the House and Senate conferees on H.R. 2400, the Transportation Reauthorization Bill, not to raid VA funds to offset spending for transportation projects. Despite passage of the motion, the conferees included a provision to eliminate compensation benefits for serviceconnected smoking-related illnesses.

In an effort to protect these benefits, two days later I supported a motion to recommit the bill to committee with binding instructions that funding for these benefits be restored and not be used to offset highway spending. Unfortunately, this motion failed by only 5 votes. In a final statement of disapproval, I voted against the final passage of H.R. 2400, which was approved despite my efforts.

As you may know, my steadfast commitment to our nation's veterans is unwavering and I have made it a top priority to devote my time and attention to providing additional resources for veterans benefits and medical care programs. If our nation rescinds its promises and ignores its obligation to those who have fought to preserve freedom throughout the world, we compromise the right to ask our men and women to serve and defend our national principles.
