AGENT ORANGE EXPOSURE - EXTERNAL CHECKLIST

Purpose: Use this checklist to assist in determining eligibility for enhanced enrollment priority group placement (e.g. no lower than Priority Group 6) for VA health care enrollment purposes.

Who: Veterans who served in Republic of Vietnam (boots on the ground or in the Brown Waters) beginning <u>January 9. 1962</u> and ending <u>May 7, 1975</u>.

What: VA provides cost-free treatment (hospital care, medical services and nursing home) for any disability possibly related to their military service, and assignment to Priority Group 6 (i.e., may meet criteria for a higher priority group).

To Confirm Agent Orange Veteran Status from a DD-214:

Step 1: Confirm active military service within dates of January 9, 1962 – May 7, 1975 <u>and</u> 'foreign service in the Republic of Vietnam (RVN)' (DD 214, Record of Service, 12f).

Step 2: Confirm active military service within dates of January 9, 1962 – May 7, 1975 and medals awarded to Veterans who serviced in Vietnam. For the Army and Marines, when Vietnam is not documented on the DD214, if one of the medals below are documented as being awarded the Veteran, service in Vietnam is confirmed. For the Navy and Air Force additional information to confirm active military service Vietnam's Brown Waters requires documentation of two or more medals.

- ➤ "Brown Water Veterans" who served aboard river patrol and swift boats that operated on inland waterways anytime between January 9, 1962 and May 7, 1975.
- A resource <u>used by the Veterans Benefits Administration</u> (VBA) for determining whether a particular <u>US Navy or Coast Guard Veteran of the Vietnam era</u> is eligible for the presumption of AO exposure based on operations of the Veteran's ship Navy and Coast Guard Ships Associated with Service in Vietnam and Exposure to Herbicide Agents is located at:

Step 3: Confirm Active military service within dates of January 9, 1962 – May 7, 1975 <u>and</u> statement of service in Vietnam is found within the narrative or remarks.
