GENERAL MURRAY'S REQUIREMENTS

10 APR 1986

- A. Furnished source material such as Army Regulations which prescribe the use of Daily Journals.
- B. Researched and developed dispersion patterns of seven U. S. Army, Battalions and plotted locations on 1:50,000 maps.
- C. Researched and provided list of FSB's, LZ's, and Main Base Camps.
- D. Researched Daily Journals for Army acronyms used in Vietnam.
- E. Provided copy of Standard Operating Procedure on Battalion Tracking.
- F. Random selected U.S. Army Chemical Unit Spray Missions from the Services Herbs Tape, requested backup documentation and demonstrated locations on maps.
- G. Provided ESG rebuttal letter to CDC interim Report No. 2.
- H. Provided extracts of assorted U.S. Army combat unit records.
- I. Interviewed employees and officers of ESG testing them on their qualifications for researching troops movements, military knowledge of map reading, organizational structure at combat battalion level and higher, availability of records, scope of retrieval from the various records holding areas and repositories world-wide, produced and demonstrated quality of the records being used.
- J. Examined troop level records of all types being utilized in the epidemiological study. Examined recording of grid locations and methodology to fill gaps.
- K. Examined Daily Air Activity Reports-random selections. These are source documents used in completing the Ranch Hand Tape.
- L. Questioned use of other chemicals by troops in Vietnam such as Malathion, and DEET.
- M. Questioned other diseases prevalent in Vietnam.
- N. Questioned the use of CW-BW by the enemy.
- O. Required Air Force to furnish roster of Ranch Hand "Handlers."
- P. Required U. S. Marine Corps to provide a report on Marine units not exposed to herbicides.

Q. Required USMC LNO to examine records and methodology used by Scientific Support personnel conducting the military research for the Agent Orange Study.

R. Examined the Personnel Data collection phase of the study including subject selection for the pilot as well as the 20,000 personnel records previously furnished CDC.

S. Reviewed the efficiency reports of the senior leadership of ESG to determine performance. Reviewed the records of outside agencies as to opinions of ESG operations.

T. Contract proposals or requests for bid for:

a. Research, keypunching and computerization of basic data from combat records.
