## This-N-That

Military Sexual Assault or MST as it's commonly referred to is still a prevalent issue that Congress is supposedly dealing with in how it's to be handled, who is to be handling it, how, and when, and the end result.

One common denominator of every war-conflict zone of the last 20 years is sexual abuse against men. And almost always goes un-reported for many reasons, guilt, shame, embarrassment, and most importantly the chain of command and how they address the issue.

But, the exact same thing can be said for women in the military and sexual abuse against them, however, seems to be worse. And those seeking benefits to help them deal with it can't get the much needed psychological help needed or monetary benefits to help them through their day to day lives because they didn't file charges, or did and some how they mysteriously vanished and nothing happened.

And as with all Veteran issues both the Congress and Veterans Affairs drag their feet, and either find ways to not adequately address the issues, or laugh them off, or just flat out ignore them as they're "not as important" as providing monetary assistance to foreign countries, or providing all the freebie programs to the illegals, Syrian refugee's, etc.

As with all issues dealing with Veteran health care, benefits, and assuring you are getting what you have more than earned, I again ask all our readers to use the phone numbers provided toward the bottom of this newsletter, call your Senators and Congressman, and demand they immediately address Veteran issues now, not tomorrow, not next year, now!

## Veterans ID Card Update

As a response to an ongoing demand from veterans for a card that would simply serve as valid proof of military service, the Veterans Identification Card Act 2015 (Public Law 114-31) was enacted this past summer (July 20, 2015). According to VA sources, they have begun the process of implementation. The Veterans Benefits Administration (VBA) has been tasked with implementing this law, which will be available nationwide.

While the law gave a deadline for implementation, the VA still must publish regulations and solicit public comment before finalizing the program. Then, the VA will be reaching out to Veterans to let them know how they can obtain the card, should they choose to request one. The cards will not be issued automatically. The law provides for the VA to charge for the cards, but at this time, the cost of the card has not been determined. As indicated in the law, these ID cards would not take the place of a VA health care enrollment card, a VA Choice Card, or any additional identification card that confers VA benefits upon the cardholder.

**Military retirees and 100% T&P veterans** are eligible for valid DoD identification cards, which are widely accepted as proof of military service/veteran status. The new VIC will help veterans who served less than a career and who are less than 100% disabled. However, there does not now appear to be any reason why anyone who is willing to pay the fee could not qualify for one.

**Note:** The card comes as a response to the request of many veterans who require proof of service to qualify for some programs and promotions from commercial enterprises, but who do not want to carry their DD-214. The DD-214 is proof of military service and has information on it which may pose a security risk if lost. Veterans Day (November 11, 2015) is coming up shortly, and there will be many restaurants (for instance) offering a free meal to veterans. However, they generally require proof of military service, which this card would satisfy. However, it is doubtful that this program will be in full swing in time for this year's holiday.

#### TRICARE: Prior Authorization

Sometimes certain types of specialty care and prescription drugs require special review called prior authorization to make sure they are right for the patient. Prior authorization is a standard process throughout the health industry. If a procedure or drug requires prior authorization, it may be because there is an equally effective treatment or therapy available at a lower cost. Prior authorization applies to more than 80 drugs under the pharmacy benefit and some **compound drugs**. TRICARE requires you to use the generic version of the drug, but prior authorization lets your doctor provide evidence to

## Study Looks at Women Veterans

A new study has found that up to one in five women who served in the U.S. Military during the 1960s and 1970s experienced post-traumatic stress disorder (PTSD) at some point in their lives and many are still living with the condition. Most of the study participants who served in Vietnam and the U.S. were members of the Army. More than half of the women in all categories were nurses during the war. About 20 percent of the women who served in Vietnam met the criteria for PTSD at some point in their lives, and about 16 percent of women who served in Vietnam still met the criteria for PTSD. An abstract of the study is available on the JAMA Psychiatry website.

## Grants for Driver Training for Vets

The U.S. Department of Transportation's Federal Motor Carrier Safety Administration (FMCSA) today announced nearly \$2.3 million in grants, double the amount provided in 2014, to 13 technical and community colleges across the country to help train veterans and their families for jobs as commercial bus and truck drivers. Also, the <a href="Military Skills Test Waiver Program">Military Skills Test Waiver Program</a> has been expanded to include all 50 states and the District of Columbia. Under this program, state licensing agencies have authority to waive the skills test portion of the CDL application for active duty or recently separated veterans who possess at least two years of safe driving experience operating a military truck or bus. ## AF Wounded Warrior Program

The Air Force Wounded Warrior program includes service members seriously wounded in combat, with major illnesses such as cancer, or severe injuries from accidents on- or off-duty. There are about 40 recovery care coordinators in the Air Force Wounded Warrior program. This job is to be is to be up-close-and-personal, dedicated advocates and problem-solvers for Airmen, including Reserve and Guard. The recovery care coordinator works up a Comprehensive Recovery Plan for the Airman based on his or her goals. The Air Force Wounded Warrior program proactively identifies qualifying Airmen from daily medical status reports sent to all major commands, but encourages self-referrals from anyone who may qualify. #### Soldier Missing From Korean War Accounted For

The Department of Defense POW/MIA Accounting Agency (DPAA) announced today that the remains of a serviceman, missing from the Korean War, have been identified and will be returned to his family for burial with full military honors.

U.S. Army Cpl. Robert E. Meyers of Greencastle, Pennsylvania, will be buried Oct. 26, in Arlington National Cemetery. Meyers, assigned to Company A, 2nd Engineer Combat Battalion, 2nd Infantry Division, was declared missing in action, Dec. 1, 1950, after his unit was involved in combat operations in the vicinity of Sonchu, North Korea. The U.S. Army declared Meyers deceased March 2, 1954.

In 1954, United Nations and communist forces exchanged the remains of war dead in what came to be called "Operation Glory." All remains recovered in Operation Glory were turned over to the Army's Central Identification Unit for analysis. The remains they were unable to identify were interred as unknowns at the National Memorial Cemetery of the Pacific in Hawaii, known as the "Punchbowl."

In 2012, due to advances in technology, the Department of Defense began to re-examine records and concluded that the possibility of identification for some of these unknowns now existed.

To identify Meyers' remains, scientists from DPAA and the Armed Forces DNA Identification Laboratory used circumstantial evidence, dental analysis, and chest radiographs, which matched Meyers' records.

Today, more than 7,800 Americans remain unaccounted for from the Korean War. Using advances in technology, identifications continue to be made from remains that were previously returned by North Korean officials or recovered by American teams.

## Armed Service Chairmen say: Reforms Ahead for Benefits and Compensation

Following a recent event at the Brookings Institution, Rep. Mac Thornberry (R-TX), chairman of the House Armed Services Committee, told reporters "TRICARE reform is going to be a key focus because access to care is not what it should be." Thornberry said work on healthcare reform will begin in the coming weeks. "There are a number of areas where we ask: 'Are we best positioned to recruit and retain top quality people in today's work environment?'

As you know, the Military Compensation and Retirement Modernization Commission (MCRMC) recommended a complete overhaul of the military health system, to include dumping TRICARE, realigning medical commands and better integrating Defense Department care with Veterans Affairs medical offerings.

At this time, it is unknown how the MCRMC recommendations may influence next year's focus on healthcare reform. However, if the MCRMC proposal on retirement is an indicator, be prepared to get out-front of the discussion. As you know, the Commission's plan to establish a blended retirement system to replace the traditional 20-year system formed the basis of reform detailed in the recently approved National Defense Authorization Act.

#### Lawmakers Set Focus on Medicare Premium Fix

Congressional efforts to block a looming premium spike for millions of Medicare beneficiaries could add upwards of \$10 billion to the cost of a budget deal but also provide powerful incentives for lawmakers to throw their weight behind an agreement.

An estimated 16.5 million seniors, or 30 percent of enrollees in Medicare Part B, are expected to see their monthly premiums for doctors' visits and outpatient services rise by at least \$54 in 2016. The remainder are protected by a "hold harmless" provision preventing Part B premiums from rising more than their Social Security paychecks.

Here's the problem: By law, Social Security beneficiaries whose Medicare premium is automatically deducted from their Social Security benefits are held harmless from Medicare premium increases if there is no COLA, which occurred this year. While this greatly assists the 70 percent of Medicare beneficiaries who are protected in this way from a reduction in their monthly Social Security benefit, it results in a disproportionate increase in premiums for the 30 percent of Medicare beneficiaries who are obligated by law to pay for the increases that are not passed onto Social Security beneficiaries. Those held-harmless beneficiaries' monthly premium will stay at \$104.90, whereas the unprotected Medicare beneficiaries will face a 52 percent increase to \$159.30 each month.

A number of House and Senate lawmakers have readied legislation to forestall the increase (S. 2148, H.R. 3696), freeze premiums for all beneficiaries, and limit other out-of-pocket costs. NAUS supports urging lawmakers to sort out this matter and fix the issue.

#### Border Jobs for Vets Act Would Bring Jobs

The <u>Border Jobs for Veterans Act</u>, which has already passed both houses of Congress, aims to connect veterans with hundreds of open positions with Customs and Border Protection. The bill would put veterans working at ports of entry across the country. People are encouraged to apply year-round for jobs with Customs and Border Protection because the application process can be lengthy. Hiring veterans could speed up that process, according to some of the bill's cosponsors like Arizona Senators John McCain and Jeff Flake. The belief is that the returning veteran would still have some form of clearance, so background checks and other tests could be much quicker. The bill is awaiting President Obama's signature. ## VA Million Veteran Program Hits Milestone

The Department of Veterans Affairs' (VA) Million Veteran Program (MVP) has enrolled its 400,000th veteran volunteer, squarely putting it on track to become one of the world's largest medical databases, linking genetic, clinical, lifestyle and military-exposure information, with the goal of learning more about the role of genes in health and disease. Veterans who volunteer for the program donate blood, from which DNA is extracted, and periodically fill out surveys about their health, health-related behaviors and military experiences. They also consent to having authorized researchers access the information in their VA electronic health record, and to being re-contacted for future research opportunities. All information is kept secure and de-identified. #### **Veterans Affairs Supportive Housing Grants**

The Veterans Affairs Supportive Housing (VASH) helps homeless veterans find housing. Through the VASH program, homeless veterans are provided a special class of Section 8 vouchers that they use at approved agencies to obtain housing. The Department of Veterans' Affairs (VA) Services for Veteran Families (SSVF) program, provides supportive services to very low-income veteran families living in or transitioning to permanent housing. Eligible veteran families are provided case management and assistance in obtaining VA and other benefits, which includes time-limited payments to third parties (such as landlords, utility companies, moving companies, and licensed child care providers) if these payments help veteran families stay in or acquire permanent housing on a sustainable basis. ## Veterans still facing major medical delays at VA hospitals

CNN reports appointment wait times at the Department of Veterans Affairs are not getting better.

Despite billions of extra dollars poured into the agency in the last year and numerous reforms intended to improve veterans' access to care, whistleblowers and internal documents obtained by CNN reveal some VA facilities continue to grapple with appointment wait times of months or more.

Even at the Phoenix VA medical center, where VA managers devised "secret" appointment lists hiding how veterans were dying waiting for care, CNN sources say complicated wait-time calculations continue to obscure ongoing appointment delays.

"The reality is veterans are waiting months -- three, six months at a time, sometimes more -- for care at the Phoenix VA," said one source in Phoenix who agreed to speak to CNN anonymously because of fears of retaliation. Click <a href="here">here</a> for full report.

#### IG Report: VA Officials Force Managers Out, Then Take Newly Vacant Jobs

At a House Committee hearing Wednesday, the Department of Veterans Affairs refused to allow five officials cited in a Veterans Affairs Office of Inspector General <u>report</u> on misuse of authority and waste of government money to appear before the House Veterans Affairs Committee for questioning.

The department alleged that allowing the officials to appear could undermine internal efforts to investigate and discipline them.

But the committee's chairman, Representative Jeff Miller, who has grown increasingly critical of the pace of change at the department, shot back at the hearing, saying that the department had too often failed to hold officials accountable.

"If we do not aggressively shed light on issues we uncover," Mr. Miller said, "V.A. will just sweep them under the rug for an extended period of time and wait for public attention to go elsewhere."

Two of the officials subpoenaed were Diana Rubens and Kimberly Graves, who oversee regional benefits offices. The committee had also planned to subpoena their boss, Undersecretary of Benefits Allison A. Hickey, but she abruptly resigned last week.

With no department officials present, the committee heard testimony instead from Linda Halliday of the Veterans Affairs Office of Inspector General. She described an investigation by the office that found that Ms. Rubens and Ms. Graves had forced other managers out of their positions and then taken the newly vacant jobs, which came with fewer responsibilities, but kept the same pay. The moves cost the government more than \$400,000 in moving costs and relocation bonuses.

"It is clear from this report," Chairman Miller said in a statement, "that Under Secretary Hickey and others in VA leadership knew they could use fear, intimidation, and timely relocation incentives to coerce subordinates to relocate to jobs they didn't apply for at the taxpayers' expense ... it is clear from day one that VA officials were using the relocation expenses program to enrich themselves. The actions of the individuals uncovered by this report are a discredit to VA employees and veterans."
