### ***VA Looks at Payments to Incarcerated Vets***

An audit by the Department of Veterans Affairs Inspector General of Veterans Benefits Administration's incarcerated veterans adjudications has found VA is failing to fulfill its duty to adjust payments in accordance with the law. The law requires VA to cut certain benefits payouts to veterans who are incarcerated for longer than 60 days. The audit found VA was not prioritizing these claims, which resulted in substantial overpayments. Once many of those veterans are released from their incarceration, they are then billed for the overpayment often resulting in hardship for the veteran. ### ***VA Not Sure How 24k Vets Were Diagnosed With TBI by Unqualified Personnel***

The Department of Veterans Affairs told a House Veterans' Affairs subcommittee last week that they don't know how 24,000 veterans were diagnosed with traumatic brain injury (TBI) by "VA physicians considered unqualified to make such a determination," according to the Air Force Times. Officials also said that the department is working to resolve related disability claims problems.

From 2007 to 2015 roughly 24,000 veterans diagnosed with TBI by a VA health provider considered to be unqualified under VA policy, and some of them were denied disability benefits.

Dave McLenachen, deputy undersecretary for disability assistance at the Veterans Benefits Administration (VBA) told the HVAC subcommittee last week that he was unable to "find a reason" why the exams were conducted in violation of VA policy at a number of VA facilities.

Apparently more than 14,000 affected veterans already are receiving disability compensation for service-connected TBI, "many at higher rates of evaluation." So telling these veterans that the VA is "going to schedule an exam without their choice, might have a significant impact on their benefits," according to McLenachen.

More than 327,000 troops were diagnosed with a brain injury from 2000 to 2015. Roughly 80 percent of those diagnoses were for mild TBI, or concussion.

Roughly 170,000 veterans with TBI have filed disability compensation claims and 75,000 have been approved.

## *VA Conducts Suicide Analysis*

The Department of Veterans Affairs (VA) has undertaken the most comprehensive analysis of veteran suicide rates in the U.S. The final report will be publicly released later this month. Key findings of the analysis will include: (1) 65 percent of all veterans who died from suicide in 2014 were 50 years of age or older; (2) veterans accounted for 18 percent of all deaths from suicide among U.S. adults; (3) since 2001, veteran suicides increased 32 percent; (4) since 2001, the rate of suicide among U.S. veterans who use VA services increased by 8.8 percent, while the rate of suicide among veterans who do not use VA services increased by 38.6 percent. ### *Survey Says Most See Vets as Heroes*

A new survey has found that the vast majority of Americans and employers see veterans as "heroes," but do not see them as "assets" within the community. This viewpoint can keep veterans from the jobs they want. The online survey of more than 2,000 veterans and non-veterans found that 84% of employers and 75% of civilians see veterans as heroes. But only 26% of employers and 22% of civilians think veterans are "strategic assets" in their communities. The numbers were almost identical to findings by Pew Research in 2011, when the same questions were asked. Survey results were released as part of a joint effort by Edelman; Give an Hour, a non-profit organization that provides counseling to troops and veterans, and the George W. Bush Institute.

### **Secretary Takes Action to Ensure Project ARCH Veterans Continue to Receive Care Closer to Home**

Augusta, Maine – As the [Project ARCH](#) pilot program comes to an end next month, Department of Veterans Affairs Secretary Robert A. McDonald today announced that Veterans enrolled in the program will be able to continue receiving care closer to home. Taking advantage of options available under the [Veterans Choice Program](#), such as the “unusual or excessive burden provision” and Provider Agreements, Veterans receiving care under Project ARCH will continue care without interruption when the pilot program ends August 7.

“There is nothing more important to us than serving the Veterans who served our country,” said Secretary McDonald. “My commitment to those Veterans under Project ARCH is that we will do everything within our control to make sure they maintain continuity of care in their communities with the providers they know.”

Project ARCH operates in Maine, Virginia, Kansas, Montana and Arizona. In anticipation of the program’s end, Project ARCH providers have been contacted and invited to continue to provide health care to Veterans under the Veterans Choice Program.

“VA appreciates the Veterans and community providers who participated in the program,” said Dr. Baligh Yehia, Assistant Deputy Under Secretary for Health for Community Care. “VA is employing lessons learned and best practices from the program as we work to build one [consolidated program for community care](#) – a program that delivers the best of both VA and the community.”

Veterans transitioning to the Veterans Choice Program are being contacted regarding their individual care.

### ***Pentagon Announces Multibillion Dollar TRICARE Contracts***

Patricia Kime of *Military Times* reports Humana Military and Health Net Federal Services are the big winners in the bid for TRICARE contracts worth potentially \$57 billion to manage the military health program over the next five years, announced by the Defense Department on Thursday.

With the change from three regions to two UnitedHealthcare, the nation's largest single health care company and official manager of the Tricare West Region since 2012 is now out of the TRICARE business.

According to the contract announcement Thursday, Humana, which now manages the Tricare South Region, will assume the contract for the new Tricare East Region, which encompasses 29 States and parts of two States and the District of Columbia.

That contract has an up-front value of \$67.5 million with an estimate of \$40.5 billion for the duration of the contract.

Health Net Federal Services, which manages the Tricare North Region, was awarded the contract for Tricare West Region, valued at more than \$49 million in the initial phase and up to \$17.7 billion over the five-year contract period. The West Region includes 19 States and portions of three States.

The Defense Health Agency has cut the number of Tricare regions from three to two in a cost-savings measure designed to streamline management oversight and cut administrative costs.

In the bidding process, companies were allowed to bid for both regions but could win only one contract and no single company would be selected to manage both regions.

Traditionally, the Tricare contract award has been a tumultuous decision, with the last contract award process started in July 2009. The Tricare North region contract was given to Aetna, the South region contract was awarded to UnitedHealth Military & Veterans Services and the West region went to TriWest Healthcare Alliance.

But HealthNet Federal Services, which originally held the North region contract, protested and eventually won the contract for that region while Humana, which held the South region, also protested and won back the contract.

A protest of that decision was then filed by UnitedHealth that was denied by the Government Accountability Office, after which the company made a case that it should be able to compete for the West region contract.

The government agreed, and in a follow-on competition for the West region, UnitedHealthCare won the contract for the Tricare West Region in March 2012.

In a statement released Thursday, a UnitedHealthCare spokesman said it was “evaluating the next steps and looks forward” to hearing the government’s explanation for its decision.

“We remain committed to serving the health care needs of our country’s military service members, retirees and their families in the TRICARE West Region,” Bruce Jasurda said. “UnitedHealthcare will continue to look for opportunities to support the Defense Health Agency to bring quality and innovative solutions to meet TRICARE beneficiaries’ health care needs.”

As is customary, the TRICARE contracts provide five, one-year options exercisable by the DoD. Final disposition of the contract award is, however, subject to the resolution of any protests that may be filed by unsuccessful bidders.

### ***DoD Consolidates TRICARE Regional Offices***

On July 1, 2016, TRICARE Regional Office (TRO) North and TRO South became TRO East. TRO West is continuing as before covering the western United States.

The move was made in advance of the pending award of the TRICARE-2017 (T-2017).

Current TRO North staff in Falls Church, Virginia, and TRO South staff in San Antonio, are functioning under the new TRO East business model. Some staff rebalancing occurred to eliminate redundancies, but each office will continue to provide management and support services in their respective geographic areas covering 33 States.

Ken Canestrini, chief operating officer for TRO East, Canestrini said having two major regional offices hits the right balance of combining operations for efficiencies while making sure not all of the eggs are in one basket.

“With just one contractor for all stateside areas, if you had any issues with a contractor or service, it would likely affect all our beneficiaries,” said Canestrini. “This way you’ll continue to have two major sectors of terrain, while still capitalizing on best practices from the different regions.”

TRO East will handle the lion’s share of those enrolled in TRICARE, with about six million beneficiaries – about two-thirds of all TRICARE beneficiaries.

Under the future T-2017 Managed Care Support Contracts, one government business partner will manage the network of civilian medical providers for the entire East Region where previously, two business partners split that responsibility in eastern geographic regions designated as North and South.

The TRICARE Regional Offices provide essential government oversight and coordination for those civilian contractors.

Canestrini said this move is one of many initiatives in the Defense Health Agency to improve the Military Health System and ensure active-duty, retirees and family members receive the highest-quality health care services for years to come.
