# Current VA Under Secretary of Health nominated to become VA Secretary

Last week, President-elect Trump nominated the present VA Under Secretary of Health to take over the top job of Secretary of the VA. It was a surprise nomination that was greeted with happiness by most VSOs including TREA. David Shulkin is an MD who has headed the VA medical section since 2015.

He is well liked and admired though there was disappointment that he is not a veteran. Indeed if he is confirmed he will be the first Secretary of the VA who is not a veteran himself or herself.

Doctor Shulkin ran several large medical istitutions including Morristown Medical Center, Goryeb Children's Hospital, Atlantic Rehabilitation Institute and as president and CEO of Beth Israel Medical Center in New York City.

The nomination leads us to believe that there will not be a major push to privatize the VA as many had worried there would be.

Mr. Trump announced the nomination during his first press conference since his election. The press conference was a dramatic affair and some of the news was lost in the shuffle, so you may not have heard of it.

The reaction from both sides of the aisle was positive. President-elect

Trump said while announcing his selection: "He's fantastic. He will do a truly great job." Dr. Shulkin responded to the appointment by saying: "It is my honor to serve as President-elect Trump's Secretary of Veterans Affairs. President-elect Trump's commitment to caring for our veterans is unquestionable, and he is eager to support the best practices for care and provide our Veterans Affairs' teams with the resources they need to improve health outcomes."

The new Chairman of the House Veterans Affairs Committee Rep. Phil Roe (R-Tenn.), said he was pleased with the choice of Shulkin:" "I am pleased President-elect Trump has chosen a physician to lead the Department of Veterans Affairs, especially one familiar with the integrating of private practitioners into the VA's network of health care providers. I've long said I would be happy to work with anyone committed to ensuring our heroes have access to the services they have earned, especially quality health care, and I look forward to working with Dr. Shulkin to bring wholesale reform to the Department."

In the Senate Chairman of the Senate Veterans Affairs Committee Sen. Johnny Isakson (R-GA) congratulated Shulkin and said he understands how to work with Congress for meaningful reform.

"There is a tremendous amount of work to be done – by the VA and by Congress – to change the paradigm at the U.S. Department of Veterans Affairs. Dr. Shulkin understands the critical importance of working hand-inhand with Congress on enacting meaningful, bipartisan reforms to help right the ship at the VA. I congratulate Dr. Shulkin on his nomination, and I look forward to chairing his confirmation hearing and discussing our shared priorities to ensure the VA is putting veterans first."

On the other side the former ranking member of the committee Rep. Mark Takano (D-CA), said Shulkin was the most qualified of Trump's potential VA candidates. He said, "After calling the Department of Veterans Affairs 'the most corrupt agency in the United States' on the campaign trail, the President-elect's decision to retain a current VA leader and Obama-appointee is a notable departure from his inflammatory rhetoric. I sincerely hope he will leave his promise to move the VA toward privatization on the campaign trail as well."

At a briefing of approximately 30 VSOs and MSOs departing Secretary Bob

McDonald and Deputy Secretary Sloan Gibson also praised David Shulkin and said that they believed he would skillfully continue the work and plans that they had been establishing for the last 2 years.

### **Navy Combat Art Program**

The Navy Combat Art Program was founded in 1941 because of the persistence of Griffith Baily Coale, a well-known muralist. Believing that war imminent, Coale convinced top Navy commanders to send him and other artists into the field. The program was revived in the Korean War and in the Vietnam era. The Navy also began sending artists to cover a broader array of naval activities in addition to combat. Following the merger of the Navy Combat Art Program with the Naval History and Heritage Command, artists have covered naval operations around the globe. The Combat Art Program is part of the Naval History and Heritage Command's (NHHC's) Navy Art Collection, which includes more than 20,000 paintings, prints, drawings and engravings. Department of Veterans Affairs New Rule on Presumptive Care Released The Department of Veterans Affairs (VA) finalized a new rule on 13 January 2017 to consider eight diseases as presumptive for service connection. This presumptive service connection provides VA disability benefits to veterans who have one of eight diseases and served for no less than 30 days (consecutive or nonconsecutive) on permanent or temporary duty at Camp Lejeune between 1 August 1953 and 31 December 1987. The eight diseases covered under the new rule are: adult leukemia; aplastic anemia and other myelodysplastic syndromes; bladder cancer; kidney cancer; liver cancer; multiple myeloma; non-Hodgkin's lymphoma; and Parkinson's disease.

The rule will become effective after a 60-day Congressional review. Following the Congressional review period, the Marine Corps will mail registrants pertinent information and updates about the VA's new rule. The rule will be effective 14 March 2017.

Congress granted the VA the authority to prescribe all rules and regulations presumptively connecting a disease to service. We appreciate efforts by the VA and Congress to support our Marines and their families.

# New Task Force Investigating for Remnants of Agent Orange

A new investigative task force will "review and record reports from the community" on the use of polychlorinated biphenyl, or PCB, DDT and Agent Orange on Guam. According to a recent news release.

The task force will reach out to the community, review records and compile recent research data, and will attempt "to correlate these environmental pollutants with an array of congenital health problems that plague the island of Guam.

Recent reports of use of the toxic herbicide Agent Orange at Andersen Air

Force Base during the 1960s and 1970s has prompted several Guam officials to request a briefing from the military detailing the handling of Agent Orange at Andersen.

The request came after 68-year-old veteran Leroy Foster went public, saying he sprayed Agent Orange at Andersen AFB. Shortly after that, local 72-year-old veteran Gerard Laitres detailed Agent Orange use he witnessed at Andersen AFB in the 1960s.

New Bill Introduced

Florida Congressman Dennis Ross, (R) of Lakeland, plans to introduce a bill next week that provides veterans who served in Guam access to the same Agent Orange presumptive benefits as those who served in Vietnam.

"We will extend to those in Guam, that if there was Agent Orange, there is a presumption that the conditions they now have that are related to that exposure will be covered under the Veterans Administration," said Congressman Ross.

Ross' proposed legislation follows a series of reports in which a Lakeland veteran admitted spraying Agent Orange at Andersen Air Force base in Guam, exposing thousands of military personnel as well as their families to the toxic herbicide.

The government did know. A 1967 report obtained by the Rand corporation, was given prepared for the assistant Secretary of Defense.

About Agent Orange it states; "One ingredient, 2,4-d is rated as very toxic." The report added people exposed to it could expect to become ill and it could kill infants.

It's Official! Veterans Will Be Compensated January 13, 2017

The Obama administration has agreed to provide disability benefits totaling more than \$2 billion to veterans who had been exposed to contaminated drinking water while assigned to Camp Lejeune in North Carolina.

The decision was made public on January 12, 2017, with a notice in the

Federal Register.

The good news for veterans exposed to contaminated drinking water at Camp Lejuene is that, beginning in March 2017, the cash payouts from the Department of Veterans Affairs (VA) may supplement VA health care already being provided to eligible veterans stationed at the Marine base for at least 30 days cumulative between August 1, 1953, and December 31, 1987. Veterans will have to submit evidence of their diagnosis and service information and dates of tour at Camp Lejeune.

The estimated taxpayer cost is \$2.2 billion over a five-year period. The VA estimates that as many as 900,000 service members were potentially exposed to the tainted water.

The new rule covers active duty, Reserve and National Guard members who developed one of eight diseases: adult leukemia, aplastic anemia, bladder cancer, kidney cancer, liver cancer, multiple myeloma, non-Hodgkin's lymphoma and Parkinson's disease.

Affected veterans who were stationed at Camp Lejeune may now submit applications for benefits, once the rule is officially published Friday, January 13, 2017. Roughly 1,400 disability claims related to Camp Lejeune are already pending, and will be reviewed immediately, according to the VA.

### **How to Report Tricare on Your Tax Return**

Tax season is here, and people are wondering how to report Tricare health coverage on a federal income tax return. The Affordable Care Act (ACA), sometimes called Obamacare, requires that all Americans have qualifying health care coverage, called minimum essential coverage (MEC). If you do not have MEC for the entire year, you may have to pay a penalty for not having the required health care coverage. For more details, see this Paycheck Chronicles post.

VA to Provide Fertility Counseling and Treatment for Certain Veterans and Spouses

WASHINGTON - The Department of Veterans Affairs (VA) announced today that it is amending its regulation regarding fertility counseling and treatment available to eligible Veterans and spouses. VA currently provides certain infertility services other than in vitro fertilization (IVF) services to Veterans as part of the medical benefits package. This interim final rule authorizes IVF for a Veteran with a service-connected disability that results in the inability of the Veteran to procreate without the use of fertility treatment. It also states that VA may provide fertility counseling and treatment using assisted reproductive technologies (ART), including IVF, to a spouse of a Veteran with a service-connected disability that results in the inability of the Veteran to procreate without the use of fertility treatment.

"I have always believed that one of the main responsibilities of a grateful nation is to make whole the men and women who have made sacrifices on our behalf," said VA Secretary Bob McDonald. "It is important that we fully understand the needs of our Veteran population, and incorporate the major scientific advances available today that can allow them to live a full life. Providing fertility counseling and treatment, including in vitro fertilization, is consistent with VA's goal of restoring reproductive capabilities of Veterans and improving the quality of their lives."

As part of the medical benefits package, VA provides many different types of fertility treatments and procedures to Veterans. These include infertility counseling, laboratory blood testing, surgical correction of structural pathology, reversal of a vasectomy or tubal ligation, medication, and various other diagnostic studies or treatments and procedures.

Full implementation of this regulation requires that VA utilize and optimize existing capabilities for care in the community and develop internal processes that will provide Veterans with a seamless path to receiving ART services. Veterans can immediately schedule appointments with their local health care system for eligibility determinations, clinical evaluation and consultation, and initial treatment as we work to build this structure.

The interim final rule was published in the Federal Register on January 19, 2017 and can be accessed here. Although the interim rule references September 30, 2017 as the date the funding expires, the funds are authorized through September 30, 2018.
