This-N-That

On behalf of our Volunteers and myself, we would like to wish all our fathers a Happy Fathers Day!

This past week I've met with a few people trying to get the HHP program started in another community and I was truly surprised at how many people still think and believe that Homeless Veterans is not a problem, "they made the choice!"

Although some media sources have done documentaries and news briefs about the situation, none have really delved into the real situation, real causes not to mention not even discussed real solutions that are having positive effects on the lives of those who were formerly homeless and many now being productive people in society again.

While I might agree to a very small degree some Veterans are

homeless by choice, but it's a very tiny percentage. And the majority are homeless due to our government and the VA not doing or not wanting to do their jobs and take care of those who served.

For many decades the answer to the problem of PTSD with VA Doctors was to prescribe extremely heavy duty and dangerous drugs to "numb" their issues and never really addressing the problem. Then in many cases would simply pull those drugs away from the Veteran after it was already too late and they became addicted.

And when Veterans who were subjected to this kind of treatment would eventually stop going to the VA, eventually some would lose benefits or failure to comply with doctors appointments, etc.

While many others were just continually denied benefits and care would just lose hope, give up and finally lose their home or apartment and being left with no options, no family would end up on the streets.

Eventually some would turn to booze and street drugs to try and cope with their "problems" and sooner or later become addicted to the street drugs or turned into alcoholics.

If our Country, our Government and the Veterans Affairs actually kept their word, did what they were supposed to do and provided benefits and care I'd like to think and believe that the homeless Veteran situation might only be a small fraction of what it is today.

Then most recently an article was released and unfortunately I don't have the link to it, but the headline was "Drug Addiction is a Choice not a Disease!" I just about went ballistic on this, no one chooses to be an addict.

I know from first hand how the VA got my uncle hooked on heavy drugs while in a VA hospital and having had his legs amputated when he returned from Vietnam. Then they turned around after increasing his doses month after month and pulled all the drugs from him, but by then it was too late they had made him a drug addict.

And even though our family did their best to get him help, he felt the drugs were the only way to remove his pain and turned to street drugs. And like many other Vietnam Veterans put in that position, he eventually over-dosed.

I can't speak for every single Veteran and I am far from being an expert on the subject, but what I would ask is think hard before speaking and proclaiming drug addiction is a choice, or that being homeless is a choice.

Four weeks we put the call out to everyone for stories they would share with us to send to members of Congress.

We've received several hundred stories and have been blast faxing to all members of Congress since four weeks ago Sunday non-stop.

It's not too late, so if you'd like to share your story and help put faces on the problems that you face in your everyday life in dealing with the VA, please send them on to my e-mail address.

Only rules are no last names, no social security numbers, no phone numbers, only first name, city and state. All other information would be redacted and isn't needed so we can insure the protections of everyone.

VA Announces Fraud, Waste and Abuse Initiative

The Department of Veterans Affairs (VA) is launching the 'Seek to Prevent Fraud, Waste and Abuse (STOP FWA)' initiative that will prevent or identify FWA. The department-wide effort will eliminate duplicative activities and explore potential partnerships with other federal agencies to capitalize on their successes in detecting fraud, waste and abuse. VA will also establish a Prevention of Fraud Waste and Abuse Advisory Committee by July 2017. The committee will provide insight into lessons learned and private-sector practices; identify analytical tools that can be used at VA to prevent FWA; and build effective STOP FWA programs that

protect VA's resources.

Senator Nelson (FL) has introduced legislation (S. 339) and Congressman Joe Wilson (SC) has introduced identical legislation in the house (HR 846) that repeals the SBP/DIC offset for survivors, sometimes referred to as the "Military Widows Tax.". President Trump has signed into law a bill that prioritizes the hiring and training of veterans to become law enforcement officers. The new law gives preference to certain Justice Department grant applications from state and local law enforcement agencies that use the money to hire veterans. State awards \$62 million to house veterans experiencing homelessness in third round of Proposition 41 Grants

The VHHP program means more homeless veterans and their families will soon have a place to call home.

SACRAMENTO – The Department of Housing and Community Development (HCD), the California Department of Veterans Affairs (CalVet), and the California Housing Finance Agency (CalHFA) announce the latest round of awards to help build or rehabilitate 12 development projects that will house and assist veterans experiencing homelessness. The awards constitute the third round of funding in the Veterans Housing and Homelessness Prevention (VHHP) program and include projects from Eureka to San Diego.

Awards for this third round of funding total approximately \$62 million. Once built, the projects will increase affordable housing units by 836 throughout the state. Of those units, 471 will be veteran-specific, with 243 of the units dedicated to chronically homeless veterans.

CalVet Secretary Dr. Vito Imbasciani affirmed California's ongoing commitment to veterans and their families to lift them out of homelessness over the long term, stating "The VHHP funding generates more than four walls and a roof for veterans who are struggling; it provides a safe place with supportive services that

create a ladder for success from chronic homelessness.”

“The men and women who were brave enough to serve our country should not have to fight another battle once they return home,” said Housing and Community Development Director, Ben Metcalf. “The VHHP program helps veterans and their families regain a sense of place, a sense of pride, and peace.”

On any given night, more than 9,600 veterans are at risk of homelessness in California, and countless more face housing instability. Instability and homelessness among women veterans and their children are also on the rise. The service-rich communities being developed through VHHP funding address many of the challenges homeless veterans face and support their movement toward self-sufficiency. To date, the VHHP program has awarded \$238 million in funding, which will result in 1970 number of housing units for veterans and their families.

Vets Get Online Access to Exchanges

Veterans can confirm eligibility to receive a lifelong military exchange online shopping by logging onto VetVerify.org, which will use information from DoD's Defense Manpower Data Center's records and inform them of their ability to access this new benefit. If a veteran's record has character of service data and that data meets the criteria for the online benefit, the Veteran will be verified

to shop. Then, beginning on Nov. 11, the veteran can log onto to the Air Force, Army, Coast Guard, Marine Corps and Navy Exchange websites at shopmyexchange.com, shopcgx.com, mymcx.com and mynavyexchange.com for tax-free shopping. If a veteran's information is incomplete, VetVerify.org will provide guidance on next steps.



[New PTSD Treatment Comparison Tool](#)

The Department of Veterans Affairs (VA) has launched a new online tool that will help Veterans compare various treatment options for post-traumatic stress disorder (PTSD). The [PTSD Treatment Decision Aid](#) is a free, interactive online tool that helps educate patients about effective treatment options for PTSD and encourages them to participate actively in decisions about their care. The tool includes information about evidence-based PTSD treatments, such as talk therapy and prescription medication options. Users can watch videos of providers explaining different treatment options and what to expect with those treatments, and

Oppose Benefit Cuts to Retirement Age Disabled Veterans Don't Reduce Disabled Vets Benefits

The Trump Administration's FY 2018 budget request reduces some VA benefits.

The proposed budget eliminates the Individual Unemployability benefit payments to retirement-age disabled veterans. Under current policies, the Individual Unemployability program allows VA to award payouts at the 100-percent disabled rate to veterans who cannot find work due to service-connected injuries, even if they are not deemed 100-percent disabled. The Administration has proposed stopping those payouts once veterans are eligible for Social Security retirement benefits. This cut would impact more than 225,000 veterans currently receiving this benefit.

Veterans receiving benefits checks from the VA would also have their annual cost-of-living-adjustment (COLA) reduced or “round down” to the nearest dollar.

The organization National Garden Clubs, Inc. serves as the lifeline for the miles and miles of Blue Star Memorial markers in America that serve as living tribute to the men and women who serve in the Armed Forces. Since the program began over 70 years ago, more than 3,000 Blue Star markers of all three types have been dedicated across the country. Often, one or more Federation of Garden Club Districts collaborates on acquiring the markers and maintaining them in perpetuity. Often a memorial garden is planted with the Blue Star markers. Don't Weaken CFPB's Office of Service Members Affairs

The House passed the "Financial CHOICE Act" (H.R. 10) which

seeks to dramatically reshape the regulation of banking and other financial activities. This legislation includes a number of provisions weakening the Consumer Financial Protection Bureau (CFPB) and its Office of Service Members Affairs.

VA Tests FitHeart App

Currently in the testing phase, the VA [FitHeart](#) app is for patients who have heart problems and are undergoing a medically supervised exercise and lifestyle program. The app is designed specifically for Veterans and can send data directly to the Department of Veterans Affairs (VA) patient-generated database. This allows care providers to view vital information from anywhere in real time and more easily prepare reports for our electronic

health record system. If the app passes field testing, it will be released nationally for use throughout the United States.



DAV action on Proposal to Eliminate Individual Unemployability Rating at Age 62

Over the past several weeks, DAV has received hundreds of inquiries from DAV members and other concerned parties regarding the proposal to eliminate the total disability rating based on Individual Unemployability (IU) benefits for veterans over the age of 62 contained in the President's fiscal year 2018 budget. Specifically, the proposal would terminate existing IU total disability ratings for veterans when they reach the minimum retirement age for Social Security purposes (age 62), or upon enactment of the proposal if the veteran is already in receipt of Social Security retirement benefits. In the May 24 House Veterans' Affairs Committee budget hearing, DAV expressed its strong opposition to this proposal. We are aware that the elimination of these benefits would affect not only the veteran's family income, but other critical ancillary benefits, such as dental coverage, Survivors' and Dependents' Educational Assistance, the Civilian Health and Medical Program of the VA (CHAMPVA), commissary and exchange privileges, and the value of Social Security benefits. Additionally, this will impact access to some state benefits such as property tax exemptions for veteran homeowners, free vehicle registration and free access to state parks.

Please be assured this is a key priority for DAV and we are trying to respond to your phone calls and email messages as quickly as possible. DAV is actively working to educate Capitol Hill lawmakers and the public about the devastating impact this proposal would have upon service-disabled veterans and their families.
