## **MORE THAN 100 MEMBERS OF CONGRESS PUSH SHULKIN FOR ANSWERS ON AGENT ORANGE BENEFITS**

More than 100 members of Congress sent a letter to Veterans Affairs Secretary David Shulkin this week, urging him to provide follow-up information from his congressional testimony earlier this year questioning the validity of Agent Orange claims by U.S. Navy veterans who served in the coastal waterways of Vietnam.

Military Veterans Advocacy, a Louisiana-based non-profit serving the interests of service members and veterans, has long advocated for the restoration of benefits for these veterans - benefits they received until a reversal of VA policy in 2002. The Blue Water Navy Vietnam Veterans Act of 2017, which was heard in committee in April and which has 295 co-sponsors, would undo the damage caused by the policy change.

"Military-Veterans Advocacy thanks these 103 Members of Congress for their support to the 90,000 veterans of the Blue Water Navy," said Cdr. John Wells (USN, Ret.), executive director of Military Veterans Advocacy. "These veterans deserve the benefits that were stripped away from them in 2002 by the then-Secretary of Veterans Affairs. We call on Secretary Shulikin to restore these benefits and to do so promptly."

In April, Wells testified before the House Veterans Affairs Subcommittee on Disability and Memorial Affairs and met with Shulkin to seek support for the policy change from both the administration and congress.

## **Congress Passes New Forever GI Bill**

The House and Senate quickly passed a bill to correct inequities under the [Post-9/11 GI Bill](#) and boost or restore [education benefits](#) for thousands of [veterans](#) and select groups of dependents and [survivors](#). Those who stand to gain from GI Bill reforms moving toward enactment include: victims of for-profit colleges that have closed; Reserve and Guard members activated under "12304b orders" which don't trigger [GI Bill eligibility](#); Purple Heart recipients whose wounds resulted in shorter tours and reduced GI Bill benefits, and survivors who qualify for GI Bill Fry Scholarships. ## **Administration Announces Veteran Telehealth Initiatives Designed to Provide Greater Access, Care**

President Trump and VA Secretary Dr. David Shulkin announced last Thursday at the White House three initiatives that will expand access to health care for Veterans across the country. Using telehealth technology and mobile applications, VA will connect with more Veterans to provide services where they live.

"This will significantly expand access to care for our Veterans, especially for those who need help in the area of mental health ... and also in suicide prevention," Trump said. "It will make a tremendous difference for the Veterans in rural locations."

Through VA Telehealth, VA can practice over 50 clinical specialties, from tele-dermatology to tele-intensive care, Shulkin explained. Many of the

Veterans using telehealth live in rural areas or far away from their closest VA medical facility.

"VA already has the largest telehealth program in the country. Last year, we had 700,000 Veterans who got telehealth services through the VA," Shulkin said.

These initiatives will expand VA's Telehealth capability in three specific areas.

After working with the White House Office of American Innovation and the Department of Justice, Shulkin announced he will be issuing a regulation that explicitly authorizes VA providers, using telehealth technologies, to serve Veterans no matter where the provider or the Veteran is located in the country. The "Anywhere to Anywhere VA Health Care" initiative will empower VA to hire providers in major metropolitan areas, where there is an abundance of clinical services and connect them to better serve Veterans in rural communities that lack sufficient medical services.

VA plans to expand its telehealth services to support convenient, high-quality care for all Veterans. To do so, Shulkin announced VA is initiating the nationwide rollout of a new application called VA Video Connect. [VA Video Connect](#) provides a secure and web-enabled video service that makes it easy for Veterans to connect with their VA providers by video on their own mobile phones or personal computers. VA Video Connect is currently being used by more than 300 VA providers at 67 hospitals and their associated clinics. It will be rolled out to VA providers and Veterans across the country over the next year.

Shulkin also announced the nationwide roll-out of an application to make it easier to schedule or change appointments with VA. The [Veteran Appointment Request app](#), or VAR for short, is an application that makes it possible for Veterans to use their smartphone, tablet or computer to schedule or modify appointments at VA facilities. The VAR capability is currently available to Veterans at several locations nationwide. [During its initial rollout, Veterans used the app](#) to book more than 4,000 appointments with their providers. VA will continue to roll out the application nationwide - bringing the capability to all VA facilities and clinics.

- Thomas Bowman, VA Deputy Secretary
- James Byrne, VA General Counsel
- Brooks Tucker, VA Assistant Secretary of Congressional and Legislative

Additionally, they unanimously approved three nominees to serve as judges to preside over the U.S. Court of Appeals for Veterans Claims:

- Michael Allen
- Amanda Meredith
- Joseph Toth

This is very good news since the VA has been severely understaffed for the last several months.

Thomas Bowman, a retired Marine Corps Colonel, was the majority staff director for the Senate VA Committee and previously was chief of staffs for Department of Veterans Affairs Secretaries Jim Nicholson and James Peake. James Byrne is also a retired Marine Corps Colonel and has been associate general counsel for Lockheed Martin since 2008. And, yes indeed Brooks Tucker is a retired Marine Corps Lt. Colonel was presently an advisor to VA Secretary Shulkin and had been a senior policy advisor to Senator Richard Burr (R-NC)

Michael Allen is a law professor and director of the Veterans Law Institute at Stetson University in Florida. Amanda Meredith is the present Deputy Staff Director and general counsel for the SVAC and Joseph Toth served as a judge advocate in the Navy. In 2011, Toth partnered with prosecutors in Afghanistan to establish rule of law in the district where the Taliban was formed.

## **SecNav and Others Confirmed by Senate**

Eight Department of Defense nominees were confirmed by a voice vote in the Senate, which increased the Pentagon staffing. The prolonged Senate process reached an agreement between both parties, confirming Richard Spencer as the new Secretary of the Navy, Ellen Lord as the new undersecretary of Defense for Acquisition and Lucian Niemeyer and Robert Hood, both as assistant secretaries of defense. The confirmations double the number of nominees for the Pentagon confirmed by the Senate. There were only seven other defense officials who went through the same process since January.



## **House Passes Veterans Bills**

The House recently approved several legislative proposals pertaining to veterans.

The proposed bills include:

- The "Global War on Terrorism Memorial Act" (H.R.873) that authorizes

the Global War on Terror Memorial Foundation to establish memorial on GWOT,

- The "Military Residency Choice Act" (H.R.282) that allow a military spouse to elect to use same residency as service member for purposes of taxation and voting, the "Veterans' Access to Child Care Act" (H.R.95), which would make a pilot program for child care at VA facilities a permanent program for veterans receiving care on a regular basis,
- The "VA Procurement Efficiency and Transparency Act" (H.R.2006) that increases transparency in VA procurement and
- The "VA Bonus Transparency Act" (H.R.1690) which requires VA to submit annual report on paying bonuses.

The bills have moved to the Senate for further consideration.



## **Air Reserve Virtual Transition Assistance**

Individual Reservists who need to complete the Congressionally-mandated Transition Assistance Program (TAP), but whose qualifying 180+ day Title 10 orders have already ended, may now complete the requirement virtually. Individual Reservists can begin scheduling the virtual program through an over-the-phone pre-separation briefing with Ms. Vernesta Harris at (478)-327-2107. Months after officially allowing transgender troops to serve openly in the military, the department may be forced to throw out those who willingly came forward after being promised they'd be protected. ## **VA May Add to List of Agent Orange-Caused Ailments**

Last week Stars and Stripes printed an article by military columnist Tom Philpott which stated that VA Secretary Shulkin will announce no later than November 1 whether VA will add to the current list of diseases and ailments that are presumed to be caused by Agent Orange or other herbicides sprayed by the U.S. military during the Vietnam war.

According to the article those diseases and ailments could include "bladder cancer, hypothyroidism and Parkinson-like symptoms without diagnosis of that particular disease. But hypertension (high blood pressure) and stroke also might be embraced, or ignored, as part of the current review."

Shulkin's decision could make thousands more Vietnam veterans eligible for VA compensation and benefits.

## **VA 'STOP PAIN' Best Practices Guidelines**

Department of Veterans Affairs Secretary David Shulkin has announced the release of VA's top eight best practices to share with others in government and the healthcare industry who work to balance pain management and opioid prescribing, based on what VA has learned over the past four years. These best practices are summed up by the acronym S.T.O.P. P.A.I.N., which stands for: (1) stepped-care model, (2) treatment alternatives/ complimentary care, (3) ongoing monitoring of usage, (4) practice guidelines, (5) prescription monitoring, (6) academic detailing, (7) informed consent for patients, and (8) naloxone distribution. ## **VA Health Care Funding Increases**

## **Six-Month Extension of CHOICE Act Passed by Congress Before Recess**

Late on August 1st the Senate joined the House in passing legislation funding the VA Choice and Quality Employment Act of 2017 with \$2.1 billion to extend the program for an additional 6 months.

The VA Choice Program authorizes veterans who live farther than 40 miles from a VA facility, or those who cannot get an appointment with the VA in under 30 days, to access care outside the U.S. Department of Veterans Affairs (VA) health care system.

## **AF Health Professions Loan Repayment Program**

Application packages for the Air Force's Health Professions Loan Repayment Program (HPLRP) will now be accepted until Sept. 1, 2017. Active-duty Biomedical Sciences Corps and Nurse Corps officers are eligible to apply. The maximum loan repayment is \$40,000 per year for up to two years, minus about 28 percent in federal income taxes. Officers may use HPLRP to repay any qualified loans obtained for their qualifying degree that allows them to hold their Air Force Specialty Code. The service commitment for HPLRP is a minimum of two years. For more information, visit [myPers](#). Select 'Active Duty Officer' from the dropdown menu and search 'HPLRP.'
