VA Authorizes Health Insurance for Service Dogs

The VA Mental Health Mobility Service Dog Initiative authorizes the veterinary health insurance benefit for service dogs of veterans with chronic mobility limitations associated with a mental health disorder. (VA does not provide service dogs; it refers veterans to accredited service dog organizations.) VA provides the veterinary health insurance benefit to eligible veterans with service dogs obtained from these organizations, when it is determined that a service dog is the optimal means for the Veteran to manage the chronic mobility impairment and live independently. The U.S. Department of Veterans Affairs (VA) announced the formation of the Veterans' Family, Caregiver, and Survivor Federal Advisory Committee, which will be chaired by former U.S. Senator Elizabeth Dole. Take Command with TRICARE Changes

Enrollments Shifting from Fiscal to Calendar Year Starting in January 2018

Starting Jan. 1, 2018, cost changes for TRICARE benefits transition from a fiscal year period to a calendar year period. Changing from fiscal year (Oct. 1 – Sept. 30) to calendar year (Jan. 1 – Dec. 31) makes the TRICARE benefit consistent with civilian health plans. The change will largely affect those plans which have an enrollment fee and are currently billed by the fiscal year.

VA 'Benefits at Discharge' Program

The Department of Veterans Affairs (VA) has redesigned the [Benefits Delivery at Discharge](#) program to enable service members to receive disability benefit decisions the day after their discharge. The redesigned program went into effect October 1. The changes are intended to increase VA's ability to conduct exams, review medical evidence, and process ratings prior to a service member's release from active duty. In most cases, VA benefits decisions will be provided the day after discharge. Service members can submit their claim from 90 to 180 days prior to discharge from active duty. Holiday Season Mailing Deadlines

Naval Supply Systems Command, in cooperation with the U.S Postal Service, Military Postal Service Agency, and Joint Military Postal Activity, has released mail-by dates for pre-Dec. 25 deliveries of holiday cards, letters, and packages. A list of the mailing deadlines is available on the U.S. Navy [website](#). Customers should check with local civilian or military post offices for information regarding size restrictions and customs declaration form requirements. Mailing restrictions apply, and some items cannot be mailed. Customers should ensure articles are packaged properly for mailing and packages do not display markings related to any type of hazardous material.

The U.S. Department of Veterans Affairs (VA) announced the awarding of up to \$8 million in grants for adaptive sports programs that will benefit disabled veterans as well as disabled members of the armed forces. Grant recipients may use the funds for planning, developing, managing and implementing adaptive sports programs. VA will distribute the grants to 96 national, regional and community programs serving all 50 states, the District of Columbia and Puerto Rico. Veterans Crisis Line: Help Prevent Suicide

Sometimes we need help to get through challenging times. Here are signs that you may need to see a mental health provider to prevent suicide: (1) anxiety or agitation; (2) anger or rage; (3) hopelessness; (4) difficulty sleeping; (5) thoughts or feelings about death or dying; (6) increased alcohol or drug use; and (7) withdrawing from friends and family. If you or a loved one is thinking or talking about death, suicide or other self-destructive behavior, call 911 or go to the nearest emergency room. VA Photo ID Cards for All Veterans Coming in November

All honorably discharged veterans of every era will be able to get a photo identification card from the Department of Veterans Affairs starting in November due to a law passed in 2015. The law, known as the [Veterans Identification Card Act 2015](#), orders the VA to issue a hard-copy photo ID to any honorably discharged veteran who applies. WHEN: Saturday, Oct. 14, 2017 – 10 a.m.

WHERE: California Vietnam Veterans Memorial in Capitol Park – 15th Street at Capitol Avenue behind the Rose Garden, Sacramento, CA 95814

EVENT: A ceremony to add the names of 14 individuals to the California Vietnam Veterans Memorial will include unveiling the names, honoring the families, and laying wreaths at the Memorial.

BACKGROUND: The Vietnam Veterans Memorial Honor Committee was created when Governor Edmund G. Brown Jr. signed Assembly Bill 287 in 2013. The Committee is tasked with compiling a list of names of California Vietnam Veterans who died as a result of illness or injuries, including documented physical or mental injuries, which can reasonably be assumed to have resulted from military service in the Vietnam War for addition to the California Vietnam Veterans Memorial.

VA Selects Delta Dental for Dental Plan

The Department of Veterans Affairs (VA) has announced that it has selected Delta Dental of California and MetLife to once again offer private dental insurance plans as part of the VA Dental Insurance Program (VADIP). The program has been extended until Dec. 31, 2021. Veterans enrolled in the VA health-care system and beneficiaries of the Civilian Health and Medical Program of the VA (CHAMPVA) can enroll in the program beginning Nov. 15, 2017, for coverage to start Dec. 1, 2017. Enrollment is voluntary and does not affect eligibility for VA outpatient dental services and treatment. **Navy College Afloat College Program
Upgraded**

The Navy College Program for Afloat College Education (NCPACE) Distance Learning (DL) will transition to individual enrollment Oct. 1. The NCPACE DL courses are self-contained (no Internet connectivity is required to complete the course), and are available at any time for eligible Sailors assigned to type two and type four sea duty. A major change to the program is that all NCPACE DL courses will now be funded using the same rate authorized for Tuition Assistance courses: \$250 per Semester Hour (SH) or equivalent.
