Toxic Wounds

Veterans for Common Sense educates and advocates regarding military toxic exposures and the Toxic Wounds that result from them.

Toxic exposures may also cause or be associated with <u>reproductive or generational health effects</u>. Some major Toxic Wound cohorts are below.

MUSTARD GAS/LEWISITE EXPERIMENTS:

Who: As many as 60,000 U.S. troops

Where: Alabama, Canal Zone (Panama), Florida, Illinois, Maryland, North Carolina, Utah, Virginia and Australia,

England, and New Guinea

When: 1943-45

Presumptives: Yes; 14 types of cancer and eye and respiratory conditions associated with mustard exposure

Registries: None

HERBICIDE TESTS AND STORAGE:

What: Agent Orange and other herbicides used in Vietnam were part of projects to test, dispose of, or store

herbicides

Who: Unknown number of U.S. troops

Where: 21 U.S. States, Puerto Rico, Cambodia, Canada, India, Korea, Laos, Thailand, and at sea

When: 1944-1970, and 1977 (at sea destruction)

FORT McCLELLAN EXPERIMENTS:

What: Chemical warfare agent and prophylaxes testing on U.S. military "line of duty" service members

Who: Unknown numbers of U.S. troops

Where: Alabama When: 19??-1999 Presumptives: No Registries: None

CAMP LEJEUNE DRINKING WATER:

What: Two water-supply systems on the Marine Corps Base Camp Lejeune in North Carolina were contaminated with the industrial solvents trichloroethylene (TCE) and perchloroethylene (PCE).

Who: Unknown number of military service members, dependents, and base civilians

Where: Camp Lejeune, North Carolina

When: August 1, 1953 (VA recognizes January 1, 1957 for family health care) through December 31, 1987

Presumptives: Yes; 8 conditions

EDGEWATER ARSENAL/ABERDEEN PROVING GROUND EXPERIMENTS:

What: Chemical warfare agent, prophylaxes, and drug testing on U.S. military service member "volunteers"

When: 1955-75

Presumptives: No (except 14 types of cancer and eye and respiratory conditions associated with mustard

exposure)

Registries: None

VIETNAM WAR & AGENT ORANGE:

What: Agent Orange and other herbicides **Who:** At least 3.5 million U.S. troops

Where: Southeast Asia; Korean demilitarized zone (DMZ); worldwide C-123 aircraft personnel

When: Vietnam, January 9, 1962 – May 7, 1975; Thailand, February 28, 1961 – May 7, 1975; Korean DMZ, April

1, 1968 – August 31, 1971; C-123 aircraft, 1972-82

Presumptives: Yes; 14 conditions

Registries: Agent Orange Registry health exam

PROJECT 112/PROJECT SHAD:

(Shipboard Hazard And Defense)

What: A series of tests of U.S. warship vulnerability to biological and chemical warfare agents

Who: More than 5,800 U.S. military personnel, mostly Navy personnel and Marines; only some of the involved

military personnel were aware of these tests at the time.

Where: Numerous locations

When: 1962-73 Presumptives: No Registries: None

PERSIAN GULF WAR:

(Operations Desert Shield/Desert Storm)

What: A "veritable toxic soup" of numerous war theatre toxic exposures, including combinations of exposures resulting in <u>Gulf War Illness</u>, experimental drugs and vaccines, Iraqi chemical warfare agents including Khamisiyah munitions depot demolitions, burning oil well fires and particulate, depleted uranium (DU), endemic diseases.

Who: Approximately 697,000 U.S. troops, unknown numbers of Coalition troops from partner countries, and local civilians similarly exposed

Where: Persian Gulf War theatre of operations

When: Aug. 2, 1990 – July 31, 1991 ("Gulf War"); Aug. 1, 1991-Present ("Southwest Asia" theatre of operations service)

Presumptives: Limited to <u>undiagnosed illness</u>, <u>chronic multisymptom illnesses</u>, and <u>nine endemic diseases</u>. No specific chemical presumptives.

GLOBAL WAR ON TERRORISM:

(Operations Enduring Freedom/Freedom's Sentinel, Operations Iraqi Freedom/New Dawn, Operation Inherent Resolve, and successor operations)

What: Numerous war theatre toxic exposures, Iraqi chemical warfare agents, open air burn pits, hexavalent chromium at Qarmat Ali, sulfur fire at Al Mishraq, depleted uranium (DU), endemic diseases.

Who: Approximately 3 million U.S. troops, unknown numbers of Coalition troops from partner countries, and local civilians similarly exposed

Where: OEF/OFS (Afghanistan) and OIF/OND/OIR/successor operations (Iraq) theatres of operation

When: October 7, 2001-Present

Presumptives: Limited to <u>undiagnosed illness</u> (Persian Gulf theatre only), <u>chronic multisymptom illnesses</u> (Persian Gulf theatre only), and <u>nine endemic diseases</u> (Persian Gulf theatre and Afghanistan). No specific

chemical presumptives.

Toxic exposures may cause or be associated with reproductive or generational health effects.

VA recognizes and offers support for the children of qualifying veterans affected by Agent Orange who have certain birth defects.

The National Academy of Sciences, Engineering, and Medicine has opined that, "there is inadequate or insufficient evidence to determine whether there is an association between parental exposure to the [chemicals of interest such as Agent Orange and other herbicides] and birth defects, childhood cancers, or disease in their children as they mature or in later generations." [Veterans and Agent Orange: Update 2014]

Nevertheless, VA has recognized that certain birth defects among veterans' children are associated with veterans' qualifying service that presumes exposures to Agent Orange or other herbicides.

- Spina bifida (except spina bifida occulta), a defect in the developing fetus that results in incomplete closing of the spine, is associated with veterans' exposure to Agent Orange or other herbicides.
- <u>Birth defects in children of women Veterans</u> are associated with their wartime military service in Vietnam but are not associated with herbicide exposure.

VA does not currently recognize or offers support for the children of veterans affected by Gulf War exposures who have birth defects.

A 2018 report of the National Academy of Sciences, Engineering, and Medicine (NASEM) evaluated "the scientific and medical literature on reproductive and developmental effects and health outcomes associated with Gulf War and Post-9/11 exposures, and designates research areas requiring further scientific study on potential health effects in the descendants of veterans of any era."

The NASEM report, entitled "Gulf War and Health: Volume 11: Generational Health Effects of Serving in the Gulf War," had numerous findings regarding adverse reproductive and generational health outcomes.

Those conclusions are summarized in the concise chart below, produced by Veterans for Common Sense from the NASEM report's findings. You may also <u>download the chart in PDF format</u>.

VA has not yet recognized any birth defects among Gulf War veterans' children as associated with veterans' qualifying Gulf War service.

VA does not currently recognize or offers support for the children of veterans affected by Camp Lejeune exposures who have birth defects.

Successive reports of the National Academy of Sciences, Engineering, and Medicine (NASEM) evaluated the scientific and medical literature on health effects related to exposure to contaminants (solvents) in the drinking water at Camp Lejeune

The NASEM reports had numerous findings regarding adverse reproductive health outcomes and the potential for adverse health outcomes in infants and children exposed to the contaminated drinking water. The reports are as follows:

VA has not yet recognized any birth defects among veterans' children associated with veterans' qualifying Camp Lejeune service.

VA does provide medical care to qualifying Camp Lejeune-exposed veterans, spouses, and children for 15 conditions:

Additionally, VA also has determined that 8 separate conditions are presumptive for VA service-connected disability claims for veterans.

"By congressional design, [it] is a unique medical research program narrowly focused on the vision of improving the health and lives of Veterans with Gulf War Illness," they wrote, calling it "a model of how to conduct treatment

oriented research to address a challenging illness" that "is succeeding where earlier programs failed."
