GENERAL TASK DESCRIPTION:

The CCTC has a requirement to automate data from handwritten coding sheets containing Services Herb Data, Unit Location Data, and Personnel Data. These data will be used in an analysis of the effect of "Agent Orange" on Vietnam Veterans. This task order provides for support of this function. The effective period of this task order is from 1 July 1982 to 31 December 1982.

SUBTASK 1: Automation of "Agent Orange" Data

a. Definition: This subtask provides for the automation of "Agent Orange" Services Herb Data, Unit Location Data, and Personnel Data. A total of approximately 10,000 coding sheets are to be converted to magnetic tape at a bi-weekly rate of 500. A magnetic tape and hardcopy listing of this data will be delivered at the end of each bi-weekly period. The final deliverable will include a magnetic tape of all data records for each of the three files listed above.

b. Deliverables:

(1) Magnetic tape and hard copy listing of converted data.

(2) Three magnetic tapes, each containing all of the data for one of the three Data files.

c. Due Dates:

(1) Every other Friday, commencing 16 July 1982, ending 31 December 1982

(2) 31 December 1982

ASSUMPTIONS:

a. The contractor will notify the Government in writing when the workload levied under the Task Order is expected to result in a premature depletion of resources or a delay in contractual effort.

b. Conflicts in effort required under the task will be called to the immediate attention of the Government in writing for resolution.

c. The project officer and the contractor will arrange for the appropriate personnel to be available for coordination meetings at mutually agreeable times. Participants should be prepared to discuss progress made, problems encountered and solutions proposed, and status of resources, relative to subject Task Order.

d. Items described under Government support will be made available to the contractor on the effective date of this Task Order.

e. Upon notification by the Government of changes or extensions in Task Order work requirements, the Project Officer and the contractor will assess the impact upon the task schedule and resources and notify the Government.
