Dear Dr. Huffaker:

Thank you for the opportunity to provide a final review of the protocols for Binghamton State Office Building (BSOB) activities. I concur with the protocals and with the revised risk assessment. I was pleased to hear that the BSOB experiences and guidelines were of assistance to the San Francisco Health Department.

I hope you will keep us informed of the status of the health surveillance activities. I'm confident that your staff will assess carefully the incorporation of questionable tests until data are available to validate their use. The morbidity phase of the Air Force Health Study, a study of 1200 men heavily exposed to Agent Orange and its associated contaminant 2,3,7,8 TCDD, will be released on February 24, 1984. I'm sure you and your staff will want to review the results in detail. I will make sure you receive a copy of the report.
