## ***This-N-That***

For many years now help for Homeless Veterans has been almost non-existent and what was or is available is almost nothing but that provided by some small private organizations as the VA's programs haven't been working even with billions of dollars dumped into the program to end Veteran Homelessness by the end of 2015.

As many of you know in Los Angeles at the West LA VAMC it's been wrapped up for a couple of years in court thanks to the ACLU and a judge ordered that all leases of Veteran property and land were illegal. This was more than a year ago and at the time the VA had filed a counter suit under Secretary Shinseki.

Finally Secretary McDonald dropped the counter suit and agreed to return the land to the Veterans. But even today there are still several Brentwood elitist businesses still there. A car rental storage lot, hotel dry cleaners, a school bus storage lot and more. And still no one is being held accountable for the revenue from those businesses which were to go to helping our Veterans.

Then a month ago Secretary McDonald and Mayor Eric Garcetti made nice for a photo opportunity to say they were going to be breaking ground soon and we still saw no activity to meet this lofty goal.

Then in January of this year Los Angeles Homeless Services Authority found a 12% jump in the overall homeless ranks and a 6% rise among homeless Veterans. And we know this number is greatly understated since the population just a few years ago was 20,000+ so with the increase which most of us anticipated is more like 25,000+ Homeless Veterans.

With a total of 387 acres which was deeded to the Veterans back in the 1800's there is more than enough room to not only renovate the 12 vacant buildings which have been vacant for more than twenty-five years and are of historical value plus all the outer buildings it certainly would not take a ton of money to get them ready for housing.

But now after all the years people have been asking Senators Feinstein and Boxer to get involved makes me wonder that their involvement now is nothing more than another photo opportunity or a final move on both their way out of office at the end of their term to say hey Veteran we're here to help!

Where has their help been in all the years they both have been in office, where has their help been in all the years people have been asking for their help? Why now? They have nothing to gain from it as they've both promised to retire at the end of their term.

With us being in the month of August and the promise being by October, it would take millions of dollars for a rush job and more likely than not they will not even come close to the goal let alone the VA's promise to end Veteran Homelessness by the end of 2015.

Finally after two long hard months, we finally have all the missing documents from the library all back on-line with and added 966 new documents and more to come. So if you've not been to the VFC website in a while, do check us out again.

Some libraries have been merged and a couple new ones have been added and we plan an estimated additional 500+ documents to be added over the next couple of weeks.

We've also added to the FAQ's (Frequently Asked Questions) a few months back, so check that out, and we also have several forums but you do need to subscribe, which is 100% free in order to see and access most forums.

Average daily downloads has been in the mid 400's with over 250,000 downloads in the past two years.

We're still asking for people to write cards and letters to be included in goodie boxes being shipped out weekly to our troops on foreign soil. We're not asking for anything special, just cards and letters to include and trust me this excites them more than the goodies we send.

And if you have children, even hand made cards from the children makes their day!

The program is called OPERATION MAIL CALL.

We're still looking for those who want to send cards and letters to our troops, not spectacular, just words of encouragement, thanks and appreciation, something to put a smile on their faces, even if only for a few seconds.

## **VA Expands Review of Chemical Exposure in Drinking Water at Marine Corps Base Camp Lejeune**

WASHINGTON – As part of VA's ongoing commitment to provide care to Veterans and their families, the Department of Veterans Affairs today announced that it will start the process of amending its regulations to establish presumptions of service connection for certain conditions resulting from exposure to contaminated drinking water at the U.S. Marine Corps Base Camp Lejeune in North Carolina.

This process is in addition to the healthcare VA already provides for 15 conditions to eligible Veterans who were stationed at Camp Lejeune for at least 30 days between August 1, 1953 and December 31, 1987 as a result of the Honoring America's Veterans and Caring for Camp Lejeune Families Act of 2012. VA also provides reimbursement of healthcare expenses for those 15 conditions to eligible family members who resided at Camp Lejeune during that time period.

The Secretary of Veterans Affairs recently met with Senators Isakson, Burr and Tillis and the Director of the Agency for Toxic Substances and Disease Registry (ATSDR) to discuss the creation of presumptions of service connection for diseases associated with the contaminated water at Camp Lejeune. The diseases that are currently being reviewed for potential presumptive service connection include kidney cancer, angiosarcoma of the liver, and acute myelogenous leukemia, which are known to be related to long-term exposure to the chemicals that were in the water at Lejeune from the 1950s through 1987. The chemicals are Benzene, Vinyl Chloride, Trichloroethylene and Perchloroethylene, which are known as volatile organic compounds, used in industrial solvents and components of fuels. ATSDR and VA representatives will meet at ATSDR offices on August 19 to begin discussions on establishing these presumptions.

VA will also work with ATSDR and potentially the National Academy of Sciences to evaluate the body of scientific knowledge and research related to exposure to these chemicals and the subsequent development of other diseases. VA will carefully consider all public comments received when determining the final scope of any presumptions.

Veterans with health problems they believe are related to exposure to the water at Camp Lejeune may file a claim for disability compensation online at [www.ebenefits.va.gov](http://www.ebenefits.va.gov), or call 1-800-827-1000 for assistance.

### ***House Passes Benefits Legislation***

The U.S. House of Representatives has approved legislation that would increase rates of benefit compensation for veterans with disabilities caused by their military service. Cost-of-living adjustments for veterans' disability benefits must be approved by Congress each year. Another provision based from legislation authored by Rep. Lee Zeldin (R-N.Y.), would require the VA to pay any accrued benefits to a deceased veteran's estate. The VA currently pays accrued benefits to a deceased veteran's family members, such as spouses or dependent children. But the VA keeps the benefit payments if the veteran dies without surviving qualifying family members.

### ***DoD Issues New Rule Under Military Lending Act***

The Department of Defense recently issued the final rule of the Military Lending Act (MLA), which covers all forms of payday loans, vehicle title loans, refund anticipation loans, deposit advance loans, installment loans, unsecured open-end lines of credit and credit cards. Among other protections, the MLA caps at 36 percent the interest rate on covered loans to active-duty service members, requires disclosures to alert service members of their rights, and prohibits creditors from requiring a service member to submit to arbitration in a dispute. The latest final rule allows for industry compliance by Oct. 1, followed by a staggered implementation period.

### ***TRICARE Tip: Answers to Your Medication Questions***

Your pharmacist should be the first resource you use to answer questions about your drugs. If you are taking over-the-counter (OTC) medications, those drugs can interfere with other medications. It is important that you tell your pharmacist about taking OTC products when you fill any prescription. The Food and Drug Administration (FDA) Division of Drug Information (DDI) will answer almost any drug question and is easy to reach by telephone at 1-855-543-DRUG (3784). If you get your prescriptions from [TRICARE Home Delivery](#), you still have access to a pharmacist 24/7 by calling Express Scripts, Inc., the contractor who manages the TRICARE prescription benefit, at 1-877-363-1303.

### ***Study Looks at Vietnam Veterans***

New research has found that four decades after the Vietnam War ended, more than 270,000 veterans who served in the war zone suffer from symptoms of post-traumatic stress disorder (PTSD). The study, published online in JAMA Psychiatry, also found that at least one-third of those veterans exhibiting symptoms of PTSD suffer from major depression, as well. ### ***New Resource Service in Chicago***

The city of Chicago has enhanced its 311 intake assessment and training process to better identify military veterans and active duty service members so they can be more easily connected to existing services and resources. Chicago residents who call 311 to request a range of services, including homeless prevention, employment services, senior well-being checks, emergency food, and crisis referral services, will be asked by a 311 operator if they are a veteran or active duty service member so they may be connected to existing resources and programs available to veterans and current military service members. ### ***Beware of DEA Extortion Scheme***

The Drug Enforcement Administration (DEA) is warning the general public about criminals posing as DEA (or other law enforcement) agents, who are part of an international money-laundering scheme. The criminals call the victims and identify themselves as DEA or other agents. The impersonators inform their victims that purchasing drugs over the Internet or by telephone is illegal and instruct their victims to pay the fine via wire transfer to a designated location. Anyone receiving a telephone call from a person purporting to be a DEA special agent or other law enforcement official seeking money should refuse the demand and report the threat at the [DEA Office of Division Control website](#) — click the 'extortion scam online reporting' link.

## **VA Launches New No-Cost Training Programs**

*Programs Designed to Help Transitioning Servicemembers and Veterans Develop New Skills and Credentials*

WASHINGTON – The Department of Veterans Affairs (VA) today launched two new no-cost training programs, Accelerated Learning Programs (ALPs) and VA Learning Hubs, to help transitioning Servicemembers and Veterans from all eras learn skills, earn credentials, and advance in civilian careers following separation from service.

ALPs and Learning Hubs are part of VA's Veterans Economic Communities Initiative (VECI), promoting education and employment opportunities for Veterans through integrated networks of support in 50 cities. VA launched the VECI program in response to President Obama's August 2014 challenge to help Veterans and families integrate with their communities and find meaningful jobs that can lead to economic success. Under VA Secretary Robert McDonald's MyVA transformation, VECI is now in place in cities across the United States.

"My message to transitioning Servicemembers is simple: Plan early and stay engaged, because transition is the mission," said McDonald. "These two new resources provide no-cost opportunities for our transitioning Servicemembers and Veterans to learn new skills and earn credentials, which can increase their competitiveness during their transition."

ALPs offer transitioning Servicemembers and Veterans the opportunity to build on their world-class training and technical skills gained through their military service, and earn certifications in high-demand fields.

VA is piloting ALPs this summer with seven courses focusing on building skills and certifications needed to advance in high-demand careers in information technology (IT), as part of the President's TechHire initiative. Each ALP course is offered at no cost and includes free referral and support services..

The first ALP cohort includes seven courses covering a range of IT-related topics, including:

- Coding/Programming Boot Camps;
- 80+ IT Certifications in Hardware, Software, Networking, Web Services, and more;
- Network Support Engineer Job Training and Certification;
- Cybersecurity Training and Certification;
- IT Help Desk Job Training; and
- IT Boot Camps for Desktop Support and Windows Expertise.

Transitioning Servicemembers and Veterans from any era are invited to apply to their choice of courses. Applications will be accepted starting August 17, 2015 – seats in the pilot cohort are limited; applicants are encouraged to apply early. ALPs do not involve use of the Post-9/11 GI Bill.. Students are able to participate in these programs while also pursuing other programs of study using Post-9/11 GI Bill benefits. Visit the ALP website to learn more about each program and apply.

VA is also launching Learning Hubs in 27 cities across the country this year in partnership with the American Red Cross, The Mission Continues and Coursera, an online education platform.

Transitioning Servicemembers and Veterans can take advantage of both online and in-person study. Each week, online course modules will be completed outside the classroom while class sessions, led by Learning Hub facilitators, provide opportunities to discuss course materials with peers, hear from subject matter experts, and network. Upon completion of the program, Servicemembers and Veterans may elect to receive one free verified certificate issued by Coursera.

## **Compound Drugs Fleece TRICARE, Create Budget Hole**

Dodgy companies peddling pricey compound pharmaceuticals have fleeced the TRICARE program so severely this year, before tougher screening procedures took effect May 1, that they are largely to blame for a \$2 billion defense health budget hole Congress is scrambling to fill. In fiscal 2010, military outpatient pharmacy costs totaled \$6.6 billion, with only \$23 million spent on compound drugs. By fiscal 2014, outpatient pharmacy costs had risen to \$7.7 billion but compound drugs costs soared to \$515 million. In the first nine months of fiscal 2015, compound drug costs tripled again for

TRICARE, to \$1.7 billion, or more than 20 percent of the \$8.2 billion TRICARE expects to spend on outpatient drugs the entire year.

### ***Weapons Permits for Vets Expedited in Florida***

The State of Florida has announced that it will expedite concealed weapons permits for active duty military and veterans. A concealed weapons permit would allow a military member or veteran to carry such weapons outside of military installations in the state. The Florida Department of Agriculture and Consumer Affairs said its goal is to issue licenses to qualified active military and veterans within 30 days, a third of the time allotted by law. ### ***University of Phoenix Under Federal Investigation***

The University of Phoenix, one of the largest recipients of GI Bill benefits, is under federal investigation for possible deceptive or unfair business practices, its parent company has announced. Apollo Education Group which owns The University of Phoenix, as well as Western International University, Carnegie Learning, and College for Financial Planning announced the Federal Trade Commission investigation in a filing with the U.S. Securities and Exchange commission. According to the filing, the investigation is to "determine if certain unnamed persons, partnerships, corporations, or others have engaged or are engaging in deceptive or unfair acts or practices in or affecting commerce in the advertising, marketing, or sale of secondary or postsecondary educational products or services or educational accreditation products or services."
