This-N-That

Well the VA is on a roll again! With more than 900,000 claims in backlog and an estimated 300,000 of those claims Veterans may have already died waiting!

Then add to that employees incorrectly marked unprocessed applications as completed and may have deleted as many as 10,000 applications during the past five years!

The VA system cannot discern how many records in the system are associated with actual applications for health care, and more than half the records did not contain an associated date of application.

Are we shocked? Are we amazed? Are we pissed off and mad as hell as YOU may be one of those applications incorrectly marked and/or deleted!

VA officials explained they cannot expunge deceased Veterans from its eligibility system because under department policy, only death notices from three sources — death certificates, a record of a death at a VA facility or a notification from the National Cemetery Administration — are considered sufficient verification.

But the not so funny thing about expunging deceased Veterans per policy isn't always the case as some of you know or have read! Many Veterans who are still living have received letters letting family know that the benefits will cease due to death, yet that Veteran is living, breathing and more than alive!

One whistleblower has been assigned a lesser job in a secluded office since raising the issue with Congress and the media, said Wednesday that he plans to send VA senior leaders and Congress his own set of recommendations.

My question is and remains, when are officials at the VA Healthcare going to realize they are in serious trouble, costing lives of countless Veterans, inflicting severe and emotional distress on family members by not facing the facts that they cannot fix the claims system?

When are they going to wake up and realize they need to bring in civilian software companies to bid on a fully functioning claims and benefits system which would first eliminate many wasted jobs to be handled by a computer system capable of determining claims and ratings all on it's own without human intervention with the exception of very complex claims?

Civilian Hospitals and Insurance Companies have been using these systems for well over a decade now and successfully as well I might add! In fact I know personally the first software application rolled out in 1978 and has been improved greatly over the years.

I will admit no software application is perfect, and I think we all know this, but something is far better than nothing, and a starting point none-the-less!

Los Angeles Mayor Eric Garcetti has backed away from his pledge to end Veteran homelessness this year stating it might take an additional six months.

My best guess is all due to the VA and having committed to and promising to rehab the twelve buildings on the West Los Angeles VA Campus and so far not having done a darn thing, nor even begun to take action.

Adding to that they still have not evicted any of the Brentwood Elitist Businesses that by a judges ruling were illegal from the onset and being able to use those buildings either.

TRICARE Pharmacy Changes Coming October 1

Starting October 1, 2015, a new law requires all [TRICARE](#) beneficiaries, except active duty service members, to get select brand name maintenance drugs through either TRICARE Pharmacy Home Delivery or from a military pharmacy. Beneficiaries who keep using a retail pharmacy for these drugs will have to pay the full cost. Maintenance drugs are those you take regularly for a long time, such as drugs to control blood pressure or cholesterol. The law does not apply to drugs you take for a short time, like antibiotics, or generic drugs. Beneficiaries living overseas, or with other prescription drug coverage, are not affected.

Support Extension of Agent Orange Act (HR 3423) Time is Running Out for Agent Orange Act

Congressman Tim Walz (MN) recently introduced the FRA-supported "Agent Orange Extension Act," (H.R. 3423) which would extend by two years the original sunset deadline of the Agent Orange Act of 1991 to ensure that Vietnam veterans exposed to Agent Orange receive just compensation and care. The Act expires on September 30, 2015 and the legislation would extend the sunset to September 30, 2017. FRA warned the House and Senate Veterans Affairs Committees regarding the sunset of the Act during its March 18, 2015 testimony.

The Agent Orange Act of 1991 (AOA) established a presumption of service connection for diseases associated with Agent Orange exposure, relieving Vietnam veterans from the burden of providing evidence that their illness was a result of military service. This law directs the the National Academy of Sciences (NAS) to periodically research and review diseases that might be associated with Agent Orange exposure. The VA is required to add diseases the NAS finds to have a positive association to Agent Orange exposure to the VA's list of presumptive service connected diseases. Since the enactment of the AOA, the NAS has issued reports that have led to the presumption of service connection for diseases such as Parkinson's, B-cell leukemia and early onset peripheral neuropathy. Without these studies, thousands of Vietnam era veterans would have gone without the benefits they greatly deserve.

If the AOA expires before the final report is issued, the VA would no longer be obligated to review the NAS report or add any new diseases to the presumption of service list, in the process denying thousands of veterans their right to compensation.

New IRS Forms for TRICARE

Under the Affordable Care Act (ACA), all military members and their eligible family members must have health care coverage that meets minimum essential coverage or pay a fee. TRICARE coverage meets the minimum essential coverage requirement under the ACA. Beginning in January 2016, the Defense Finance and Accounting Service (DFAS) will provide the appropriate IRS Form 1095 to all troops, annuitants, former spouses and all other individuals having TRICARE coverage during all or any portion of tax year 2015. The IRS Form 1095 is proof people have the minimum essential coverage. People with a myPay account at mypay.dfas.mil/mypay.aspx should logon and ensure their email

address is current as well as make an IRS Form 1095 delivery method election. For more information on the ACA, visit the IRS website at www.irs.gov/Affordable-Care-Act.

NY State Vet License Fees to be Refunded

New York State veterans who paid a fee to receive a distinguishing mark on their driver's license or ID after October, 2012 will now be eligible for a reimbursement. Last year, a bill was signed into law suspending the fee for veterans who are eligible to receive a special indicator on their Department of Motor Vehicles documents, but many veterans had been paying the fee since October 2012. The retroactive measure was signed into law in August, 2015. Each eligible veteran will receive a letter and a refund check from the state automatically. TRICARE Fraud Warning

TRICARE is warning of mailings by a bogus organization identifying themselves as TRICARE SURVEY INC. The mailings have been sent to TRICARE beneficiaries across the country and are attempting to solicit beneficiary to be "Secret Shoppers" for TRICARE. TRICARE does not employ "Secret Shoppers". Enclosed in the mailing is a form letter, a counterfeit TRICARE WPS check for \$3,775.00, and an instruction/survey form. Should you the receive a letter, do not contact the company or attempt to cash the counterfeit check. Also, submit a Fraudline report to the Defense Health Agency, Office of Program Integrity (DHA PI) by clicking the "Report Health Care Fraud" button at the Health.mil webpage at www.health.mil/fraud.

Military Commissary and Exchange Privileges for Disabled Veterans

On March 4, 2015, Representative Jeff Fortenberry (NE) introduced H.R. 1292, a bill that would authorize compensably disabled service-connected veterans and their dependents access to Department of Defense exchange and commissary facilities. Their access to these facilities would be on the same basis as if they were members or dependents of the armed forces entitled to retired or retainer pay.

This bill is in alignment with longstanding DAV Resolution 095, which calls for legislation to extend commissary and exchange privileges to service-connected disabled veterans and their dependents.

Please write your Representative to urge support and passage of this important legislation, a longstanding priority of DAV for its members and disabled veterans everywhere.

Update on GI Bill In-State Tuition; Section 702 of the Choice Act

Colleagues and Fellow Veterans,

We'd like to update you on the tremendous progress implementing our piece of the Veterans Access, Choice, and Accountability Act of 2014 ("the Choice Act") – specifically, the provision affecting students using the Post-9/11 GI Bill® and Montgomery GI Bill.

Section 702 of the Choice Act requires VA to disapprove programs at public colleges for Post-9/11 GI Bill and MGIB benefits that don't provide the resident-rate tuition and fee charges to *covered individuals*. The disapproval applies to any terms beginning after July 1, 2015. This change affects thousands of Post-9/11 GI Bill and MGIB – AD students. To remain approved for VA's GI Bill programs, schools must charge in-state tuition and fee amounts to those covered by this law.

When we last wrote about this in [May](#), we indicated that Secretary McDonald decided to exercise his waiver authority and grant more time for states and territories to comply.

Today we're pleased to report that 45 states and several territories comply with the law and have begun charging *covered individuals* up to the resident-rate for tuition and fees at public schools.

This means that nearly 5,000 public schools, covering nearly 93% of the GI Bill student population, are participating. Now, that doesn't mean that all of their students will qualify; the school still has to verify that someone is a covered individual. But it does demonstrate the breadth and depth of the progress we've made thanks to your support.

This effort took energy and support from so many people and organizations, and I'm proud of how we worked together for the greater good of the Veteran community. I especially want to thank our SAA colleagues for ensuring their respective legislative bodies or education commissions took the necessary steps to comply.

Other states have delegated the compliance decision to their respective schools ...you can see which ones at the link below.

The remaining few non-compliant states and territories have until December 31, 2015, to comply, thanks to the Secretary's waiver. All of them have indicated they intend to comply.

Our work isn't done yet, but we are so close. We won't stop until every state and territory complies, and we'll continue to update you on our progress.

Minnesota, Wisconsin Vets Get Hit With Copays

Minnesota's congressional delegation, led by Rep. John Kline, is fighting a Department of Veterans Affairs (VA) directive that found veterans suddenly being billed for co-payments that were as much as five years old. Recently, the VA discovered unbilled copay amounts for inpatient care provided to veterans over a five-year period. Veterans were going to be assessed copays ranging from \$1,000 to \$3,000 because the VA erred in not charging the veterans at the time of the care. Veterans in Minnesota and Wisconsin were to be affected, prompting members of Minnesota's and Wisconsin's congressional delegation to sign a letter to VA Secretary Bob McDonald. McDonald said every affected vet would be personally contacted about setting up a payment plan or applying for a waiver. The incident affected only vets served by the Minneapolis VA Medical Center and amounted to \$549,198. For more information, visit [Rep. John Kline's website](#).

Tax Relief in Vets in Illinois

A new law in Illinois is increasing relief of property tax for disabled Illinois military veterans. The law expands eligibility for the Disabled Veterans' Standard Homestead Exemption for United States Department of Veterans Affairs certified service-connected disabilities of 30 percent or more. Under the new law, veterans with disabilities between 30 to 49 percent will be entitled to a \$2,500 annual exemption; those with disabilities between 50 and 69 percent will be eligible for a \$5,000 annual exemption; and those who are 70 percent disabled or more will be exempt from paying property taxes. Disabled veterans will see these savings when they pay their property taxes in 2016. VA/DoD Online Service Tops 5 Million Users *eBenefits Growth Surpasses Goal Two Months Early*

WASHINGTON – Participation in the joint Department of Veterans Affairs (VA) and Department of Defense (DoD) [eBenefits](#) website topped five million users this week, two months ahead of schedule. VA established an agency priority goal of reaching five million eBenefits users by the end of fiscal year 2015. VA achieved this early milestone through aggressive outreach efforts and with the support of DoD and its Veterans Service Organization partners.

"Veterans are encouraged to enroll in eBenefits and file their claims online through this one-stop shop for benefits-related tools and information," said Under Secretary for Benefits Allison Hickey. "We have already implemented nearly 60 self-service features and we continue to expand eBenefits capabilities to give Veterans and Servicemembers greater flexibility in securing their information."

The number of eBenefits users is a key measure of VA's success in improving Veterans' access to VA benefits and services and is reported on www.performance.gov.

To enroll in *eBenefits*, Veterans and Servicemembers must obtain a DoD Self-Service Logon (DS Logon), which provides access to several Veterans and military benefits resources using a single username and password. The service is free and may be obtained online at www.ebenefits.va.gov or in person at a VA Regional Office.

"The successful collaboration of eBenefits and DS Logon is just one more example of how the DoD and VA are working together to continue bringing current and former Servicemembers secure online access to the benefits they've earned," said Mary Dixon, Director of Defense Manpower Data Center.

The rapid and continued growth in the utilization of the eBenefits website demonstrates the importance of giving Veterans greater access to information about their own benefits. In addition to filing claims online and checking the status of those claims, Veterans can also message their VA doctor, order prescription drug refills and obtain official military documents through *eBenefits*. More than 7.5 million VA letters have been generated and downloaded by Veterans that show proof of disability, income or Veterans preference used in federal or state government hiring.

Changes Coming to TRICARE Pharmacy Benefit

Starting October 1, 2015, a new law requires all TRICARE beneficiaries, except active duty service members, to get select brand name maintenance drugs through either TRICARE Pharmacy Home Delivery or from a military pharmacy. Beneficiaries who keep using a retail pharmacy for these drugs will have to pay the full cost.

Maintenance drugs are those you take regularly for a long time, such as drugs to control blood pressure or cholesterol. The law does not apply to drugs you take for a short time, like antibiotics, or generic drugs. Beneficiaries living overseas, or with other prescription drug coverage, are not affected.

The TRICARE pharmacy contractor, Express Scripts, is sending a letter to beneficiaries taking an affected drug, explaining their options. Beneficiaries can contact Express Scripts at 1-877-363-1303 to see if they are affected.

After October 1, beneficiaries still filling an affected drug at a retail pharmacy will receive another letter informing them of the change to the benefit. After that, beneficiaries have one final "courtesy" fill at a retail pharmacy. If they fill at a retail pharmacy again, they have to pay 100 percent of the cost of their medication.

TRICARE Pharmacy Home Delivery is a safe, convenient and low cost option to get maintenance drugs. You can get up to a 90-day supply, as opposed to a 30-day supply from a retail pharmacy. You save up to \$176 a year for every brand name drug you switch to Home Delivery. Military pharmacies offer up to a 90-day supply of drugs at zero copay, but not all drugs are available. You can check with your [local military pharmacy](#) to see if they carry your prescription. For more information about this change to TRICARE's pharmacy benefit, visit www.tricare.mil/RxNewRules.

In-State Tuition for Veterans

Thanks to a new law, veterans will not have to worry about paying out-of-state tuition at any public university. The Veterans Access, Choice, and Accountability Act of 2014 expands a veteran's ability to maximize his or her Post-9/11 GI Bill benefit and use that benefit at any public school in the nation regardless of residency restrictions. The current maximum tuition benefit is just over \$20,000. Many states already offer in-state tuition to any veteran, but there are **18 states that are** affected by this new law. Space-A Eligibility Changed

Without any fanfare, on 9 June 2015, the eligibility requirements to use Space A travel within the Continental United States (CONUS) **were extended** to include the dependents of service members who are deployed for 30 days or longer.

This is going to be a great benefit for families who might want to travel during deployment and can use Space A to cut costs.

Many years ago, spouses and children were not able to use Space A travel benefits within CONUS except under very limited circumstances such as emergency leave and TDY for house hunting. In recent years, the rules have been revised a few times to include dependents whose service member was deployed for a specified period of time.

This recent change, to 30 days deployment for eligibility, represents the most generous CONUS Space A benefits to date.

Dependents gaining their Space-A eligibility due to service member deployment will be Category IV in priority. Those requesting travel will require a memo detailing their eligibility, and a **[sample memo](#)** can be found at the AMC website. This definitely requires a little pre-planning to have the eligibility memo before you start the travel process.

Unfortunately this change only applies to dependents of active duty members.

Congress Has Much to do When It Returns

Congress returns next week after a month-long recess. There are many pressing issues that need to be rapidly addressed.

Of great importance is the National Defense Authorization Act (NDAA). Negotiations continue between the members and staff of the House and Senate Committees.

While nothing has been confirmed NAUS understands a number of issues remain unresolved including an increase in TRICARE prescription costs; the changes in BAH for married service members; some details in the blended retirement system; and Commissary support, which we hear may result in a pilot program instead of a more harmful decision. Additionally a pay raise for military members has, in effect, been decided by the President when he sent letters to Congress last Friday ordering a 1.3 percent increase for military members.

As you know there will be a vote taken on the Iran Nuclear deal which will take a minimum of several days and maybe more. Also negotiations on a Continuing Resolution (CR) is a must-pass to ensure that the government continues to run on October 1 after the 2015 fiscal year runs out. On this important bill reports suggest that there may be a year-long CR, which if is true will take much negotiations to ensure that our national security and readiness is not undercut.

NAUS encourages all members of Congress and their staffs to work hard and give the American people the best NDAA that they can. In the Constitution one of the first requirements of Congress is to provide for the "common defense." Unfortunately it sometimes appears members put more parochial issues first.
