This-N-That

Finally, someone in the VA seems to have grown a pair. Although it's a small step, it's better than no step at all.

Deputy Secretary Sloan Gibson told the Merit System Protection Board (MSPB) that their decision was not enforceable and that senior executive Linda Weiss would not be reinstated to her position.

Officials at VA are now trying to figure out how to bypass the Board procedures to allow termination of all bad executives without a fuss. This would include Kim Graves and Diana Rubens which involved \$400,000.00.

Again, on the bad side of the VA, the Crisis Hotline which was featured in a recent Oscar-winning documentary has allowed calls to go to voice mail, unanswered, and forwarded to lesser staffed, lesser trained staff to handle the calls, and most likely the reason for more Veterans resorting to Suicide.

The main call center, in Canandaigua, N.Y., has let some calls fall to one of its backup centers — where lesser-trained responders left calls unanswered, according to the report. Calls to backup centers are not monitored by the VA.

Those callers "did not always receive immediate assistance from VCL and/or backup center staff," the report says, and the center "did not provide social assistance with adequate orientation and ongoing training."

The report confirmed about 20 complaints over lost calls in fiscal year 2014. But I'm sure that's only the number of those Veterans who actually filed complaints, and doesn't take into account all the dropped calls, calls sent to voice mail, and certainly doesn't account for calls forwarded to outsourced services.

In my humble opinion after working with many Veterans for nearly ten years now, there are two era's who have been treated the worst when it comes to claims for illnesses. Korean Service Veterans and Blue Water Navy Veterans.

But there is a way WE all can help at least Blue Water Navy Veterans who still to this day suffer and are continually denied claims.

The House bill, HR 969, has 300 co-sponsors. The Senate bill Gillibrand introduced, S-681, has just 37 co-sponsors, so that is where Belanger is concentrating her considerable energy.

We need to get on the phones and call our Congressmen and Senators, then get on to their individual web sites and send a message demanding their support of these two bills.

Further down in this newsletter as with all we publish we provide phone numbers you can use to call you reps in DC and those lines are open 24/7/365 so call often day and night and leave a message or tell the person who answers in the respective offices to support these bills.

I want to thank those who have e-Mailed me the issued you have each had in dealing with the VA. Every little bit helps and some of you I've not responded to as of yet, but I promise by the end of the weekend I will respond.

I didn't expect the response we received to our request, but I am very thankful more Veterans are coming forward.

I continue to do a fax blast to all 535 members of Congress and I bullet point the complaints, problems, issues be they with Veterans or the VA in general. So please, keep writing to me!

We've recently added polling back to our website and we've activated all 60 survey questions, and I have one little bug to fix today, but the polls are working, so please help us to help you and visit the <u>VFC website</u> and take the time to answer as many of the poll questions as you can!

VA Budget Proposed

In his FY 2017 budget, President Obama is proposing \$182.3 billion for the Department of Veterans Affairs (VA). The FY 2017 budget includes \$78.7 billion in discretionary funding, largely for health care and \$103.6 billion for mandatory benefit programs such as disability compensation and pensions. The \$78.7 billion for discretionary spending is \$3.6 billion (4.9 percent) above the 2016 enacted level. The President's Budget also provides for continued implementation of the Veterans Benefits Administration's (VBA) Transformation Plan to systematically improve the quality and efficiency of claims processing. The Budget also requests \$1.6 billion for programs to prevent or reduce Veteran homelessness. For more information, visit the VA website.

VA CONTINUES DENIAL OF AGENT ORANGE BENEFITS FOR 174,000 NAVY VETS

The Department of Veterans Affairs late Friday afternoon issued a revision to their manual defining what areas can be considered for the presumption of Agent Orange exposure. This revision continues the exclusion of the crews of ships that entered the major bays and harbors of Vietnam. The provision was disseminated in response to a court order issued last April by the Court of Appeals for Veterans Claims. This decision entitled *Gray v. McDonald*, found that the old regulation to be improper and ordering the VA to re-write it.

In a letter to VA Deputy Secretary Sloan Gibson, Military-Veterans Advocacy Executive Director, Commander John B. Wells, USN (Retired) described the new regulation as a "betrayal." "It does not change their old rule," Wells noted. "It merely restates it with language that the court found to be irrational."

The new regulation comes on the heels of two meetings between Wells and Gibson and rescission of a draft regulation containing similar wording. The Wells letter, e-mailed Sunday evening noted: "[Y]ou have ignored scientific evidence and basic common sense to reiterate a position that was untenable prior to *Gray* and is untenable now. As I carefully demonstrated to you during our July meeting, the proven hydrological effects of the river discharge carried the contaminated waters far out to sea. We provided you with river studies showing that the Mekong River discharge plume would travel for hundreds of kilometers in a few weeks. We also presented you with information confirming Agent Orange runoff into Da Nang Harbor. Finally we furnished you with documented and incontrivable proof that Agent Orange had infiltrated Nha Trang Harbor."

"These folks got a straight shot into their drinking water." Wells said. "Studies conducted for the Australian Department of Veterans Affairs and confirmed by the United States' Institute of Medicine have proven that. Yet the bureaucrats at the VA refuse to accept the fact that they were wrong." Australia has granted the presumption of exposure to their shipboard veterans since 2003. David R. McLenachen, Acting Deputy Under Secretary for Disability Assistance, Veterans Benefits Administration, U.S. Department of Veterans Affairs acknowledged the validity of the study under questioning from Senators at a Veterans Affairs Committee hearing on September 29, 2015.

In his correspondence to Gibson, Wells went on to note: "I have a feeling of personal betrayal since I made the mistake of trusting you. In answer to a direct question during our September meeting, you assured me that you were "leaning closely to our views." In reliance upon your assurances I agreed to ask the Veterans Affairs Committees in the House and Senate to allow you an opportunity to issue a reasonable and rational regulation. I also delayed several court filings. While that deception may have allowed you to continue to stall the process, I can assure you that this delay will not affect the final outcome."

Wells promised continued pressure in Congress and the courts. HR 969 which would expand the presumption of exposure to the territorial seas is pending in the House Veterans Affairs Committee with 298 co-sponsors. The Companion Senate bill, S 681, has 37 cosponsors.

Currently litigation is pending before the United States Court of Appeals for the DC Circuit and the Court of Appeals for Veterans Claims.

The presumption of exposure was stripped from the Navy veterans in 2002 when the VA implemented a General Counsel's opinion that the requirement for air, land or naval service in the Republic of Vietnam limited the provisions of the Agent Orange Act to the land mass and internal rivers. This finding is in spite of the United States recognition of Vietnamese sovereignty over the territorial seas in the 1954 Geneva Accords and the 1973 Paris Peace Treaty. Wells continued to express dismay and disgust at the VA action. Again addressing Gibson he noted: "Your office, and that of the Secretary carries with it a special responsibility to care for our nation's veterans. Phony platitudes in correspondence and press releases are not enough when your actions cause them to ring hypocritical. The decision to put bureaucracy before honor and mendacity before veracity merely are illustrations of why the nation's veterans loathe the VA. Congress and the veterans community agree that you have broken faith with the American veteran."

Wells, who served on several Navy ships and is a retired surface warfare officer. He is now an attorney practicing military and veterans law. He is recognized nationally as the subject matter expert on the Blue Water Navy matter.

DoD Proposes a 1.6% Pay Increase for 2017

A 1.6-percent pay raise for military members was proposed as part of the president's fiscal 2017 budget. But, by law troops are to supposed to receive a pay raise within 0.5 percent of the civilian sector wages as determined by the Employment Cost Index. The index for 2017 is projected to be 2.1 percent, according to the Congressional Budget Office. Some in the House of Representatives are vowing to fight for a larger pay increase for troops.

DoD Budget Hints at More Future Force Initiatives

The U.S. Defense Department's proposed fiscal 2017 budget details the various new initiatives designed to make the military more attractive to potential recruits — from expanded maternity leave to a corporate fellows program — and hints at more efforts to come. The \$583 billion spending plan — the largest of any federal agency — references the 20 personnel reforms the Pentagon has unveiled since Defense Secretary Ashton Carter first announced the so-called "Force of the Future" program in November.

DoD Seeks to Delay Matching Retirement Benefit

The U.S. Defense Department's <u>proposed budget for fiscal 2017</u> seeks to rein in the military's new retirement system recently passed by Congress by delaying when junior troops can begin receiving matching contributions, a budget analyst said. In documents released Tuesday as part of the proposed budget for the fiscal year that begins Oct. 1, the Pentagon indicated it wants to change when service members can begin receiving matching retirement contributions — from their third year of service to their fifth year of service.

What are the differences between a claim and an appeal with the Department of Veterans Affairs (VA)? You submit a *claim* when seeking VA disability benefits (or increased benefits) for one or more medical conditions you believe are related to military service. These claims can be filed online through eBenefits, submitted by mail or in person at the

nearest VA regional office. The multi-stage appellate process is available to you after you have already received one or more decisions on your claim, but disagree with some aspect of VA's decision For more information, read the VA

Million Veterans Blood Sample Program

The goal of the Department of Veterans Affairs (VA) Million Veterans Program is to collect blood samples of at least a million veterans, and use it to research illnesses. The veterans' blood samples could hold the key to understanding causes and discovering treatments and cures for myriad illnesses. The VA is looking at some 750,000 genetic markers that medical researchers believe could be linked to illnesses that plague veterans, ranging from cancers to heart disease, kidney disease to post-traumatic stress disorder. Veteran Legal Clinics in Virginia

The Virginia State Bar (VSB) and the Virginia Department of Veterans Services (DVS) are teaming up in March to provide a series of four pro bono veterans legal services clinics to low-income veterans. Army Budget Cuts Modernization and Personnel

A shrinking U.S. Army has rolled out its proposed fiscal 2017 budget — a plan that funnels more money into readiness but cuts every other area including personnel, modernization and construction. The Army's active component takes the biggest hit to personnel compared to other services. The Army is the largest service, but its active force is scheduled to shrink from 475,000 to 460,000 — that's a 3-percent decrease, compared to the Navy's 1-percent cut to its active component. Both the Air Force and the Marine Corps have no planned cuts to their active components, according to budget documents.

GI Bill Transfer Update: Questions Answered

So you heard that there are changes underway to transferring the post-9/11 GI Bill. You know what was proposed, but now you want to know: what actually happened and what does it mean? You're not the only one asking — we've received tons of questions from users wanting the inside scoop. Here's what you need to know in this fact sheet.

TRICARE Pharmacy Changes

Several changes to the TRICARE pharmacy benefit took effect on Feb. 1. Copays for drugs filled at retail pharmacies and TRICARE Pharmacy Home Delivery increased slightly. Also, TRICARE Over-the-Counter (OTC) drug coverage became a full and permanent part of the TRICARE benefit, requiring that beneficiaries pay the usual generic copays. If you get your drugs from a military pharmacy, or use Home Delivery to get a generic drug, you will still pay \$0. To view all the new copays, visit the TRICARE Prescription Costs webpage. DoD to Send Out IRS Health Care Tax Forms

Department of Defense (DoD) civilian and military personnel will begin receiving Internal Revenue Service Form 1095 soon to complete their 2015 federal tax returns. Service members will receive an IRS Form 1095-B or 1095-C for their TRICARE coverage. Military retirees and annuitants will get Form 1095-B. DoD civilians will receive a Form 1095-C from their Pay Center and a 1095-B from their Federal Employee Health Benefit carrier. Taxpayers should review their 1095 forms for. Any incorrect information for filers and their family members should be reported to MyPay, the Defense Finance and Accounting Service, personnel offices and the Defense Enrollment Eligibility Reporting System (DEERS).

VA Boosts Budget for Outstanding Health Claims

The Veterans Affairs Department is requesting a budget of \$182 billion next year, a nearly \$20 billion funding increase designed in part to tackle outstanding health care claims from veterans. The proposed spending plan unveiled on Tuesday includes nearly \$103.6 billion for mandatory programs such as disability compensation and pensions, and more than \$78 billion in discretionary funding — mostly for health care.

Navy Installations Enforce REAL ID Act

Navy installations worldwide will no longer authorize base access for individuals who do not have an approved U.S. Government-issued credential or state driver's license that is compliant with the REAL ID Act of 2005. Driver's licenses from Minnesota, Illinois, Missouri, New Mexico, Washington, and American Samoa will require a secondary form of identification. Examples of acceptable identification include a U.S. Passport or passport card; employment authorization document (card); foreign passport with an I-551 stamp; federal, state or local government ID, Social Security card without restrictions; student ID with photo; original or certified copy of a birth certificate issued in the U.S., or a Native American Tribal document U.S. Citizen identification card (Form I-179).
