## ***This-N-That***

This past couple of weeks I'm sure you have noticed a drastic change in the newsletter. While we're still learning, it has taken on a whole new look and hopefully more over time we will learn a lot more and produce a more polished newsletter than in the past with the new software.

We'd also like to ask all our readers for ideas on a new picture to use for Operation Mail Call. Credit will be given to whom ever took the picture, and the person for their submission.

The inspector general has released information in regard to the patient wait times and that manipulation gave the false impression that the facilities in Arkansas, California, Delaware, Illinois, New York, Texas and Vermont were meeting VA performance measures for shorter wait times.

Since the Phoenix VA wait-time scandal in 2014 how widespread scheduling manipulation was throughout the VA. Investigators previously have said manipulation was "systemic" but they did not identify which facilities had problems and how serious they were.

The investigations found that employees at 40 VA medical facilities in 19 states and Puerto Rico regularly "zeroed out" Veteran wait times, which masked growing demand as new waves of Veterans returned from wars in Iraq and Afghanistan and as Vietnam Veterans aged and needed more health care.

What I'd like to know is just how much this investigation has cost taxpayers and Veterans, and precisely what is being done about it to rectify it since they can't seem to terminate employees over this problem and the facility Directors are still profiting by this action with their outrageous annual bonuses which Congress in their infinite wisdom protected.

What I find even more interesting as I continue to push on this issue are all the VA Employees who are defending themselves saying it never happened, or that it's old news and the problems have been fixed.

Yet, more and more I am hearing from Veterans all across the country of a whole new appointment problem!

Veterans who get an appointment, regardless of how long out that appointment is usually receive an automated appointment confirmation phone call, and even though you follow the automated instructions to confirm your appointment, the system is canceling your appointment and when you show up, you can't be seen as your appointment was canceled.

Then you're forced to wait weeks or months on getting a new appointment, so this seems to me in regard to the VA, this is business as usual and we go on rewarding VA Directors with their massive bonuses for keeping their wait times down.

We still see no real change or improvement in claims processing. And the blame seems to be being placed on the number of Veterans applying for benefit having quadrupled over the last four to five years.

Point of fact, claims are still being processed in the same old fashioned manner, and the decisions are still pretty much based on the "mood" of the processor.

You can have two identical claims, one on the East Coast and one on the West Coast, and voila, end result are two entirely difference decisions.

So what ever happened to the rules and regulations that were laid down in the adjudication of Veterans Claims? It's left up to humans to decide.

This is the problem! It doesn't take much to locate a "claims" processing software package in the civilian world and adapt to the Veteran/Military world. So why aren't they looking into this?

Cost has nothing to do with it as the software exists and modification programming time would not be difficult, but we rely on the VA's IT department to program the software which year after year has produced nothing but failures at the rate of billions of dollars.

So to me personally it's a matter of how much they can spend and waste repeatedly at the cost of human lives!

### ***Hundreds of Disabled Veterans to Attend 30<sup>th</sup> Winter Sports Clinic***

Washington – Nearly 400 disabled Veterans are hitting the slopes this week at the National Disabled Veterans Winter Sports Clinic in Snowmass Village, Colorado. The Clinic, sponsored by the Department of Veterans Affairs (VA) and DAV (Disabled American Veterans), is the largest adaptive event of its kind in the world and will take place April 3 – 8.

“This Clinic is an excellent example of how VA uses a holistic healthcare model to provide every Veteran with physical and mental treatment options that work for them,” said Secretary of Veterans Affairs Robert A. McDonald. “Through sports and other forms of recreation therapy, we can greatly improve the quality of life for many of our nation’s heroes.”

The Clinic teaches Veterans with disabilities about adaptive Alpine and Nordic skiing. It also introduces them to a number of other adaptive recreational activities and sports. Now in its 30<sup>th</sup> year, the clinic is an annual rehabilitation program open to U.S. military Veterans with traumatic brain injuries, spinal cord injuries, orthopedic amputations, visual impairments, certain neurological problems, and other disabilities who receive care at a VA medical facility or military treatment center.

“This event changes lives for some of our most profoundly injured military Veterans,” said DAV National Commander Moses A. McIntosh. “It’s inspiring to see how it changes their lives. We’re proud to partner with the VA and a wide range of private, non-profit and corporate donors to make these ‘miracles on a mountainside’ possible.”

### **TRICARE: State of *Emergency* in Wisconsin**

The Governor of Wisconsin has declared a State of Emergency for the entire state due to severe winter weather. Emergency prescription refill procedures are in place through 04/23/2016. To get an emergency refill, take your prescription bottle to any TRICARE retail network pharmacy. To find a network pharmacy, call Express Scripts at 1-877-363-1303 or search the [network pharmacy locator](#). If possible, visit the pharmacy where the prescription was filled. If you use a retail chain, you can fill your prescription at another store in that chain. If your provider is available, he or she may call in a new prescription to any network pharmacy. You can request assistance at another pharmacy, but it is at that pharmacy's discretion to help you.

## **VA to Resolve Claim Errors for 14K Vets**

The Department of Veterans Affairs (VA) has announced that its Beneficiary Fiduciary Field System has allowed it to identify claim processing errors affecting approximately 14,000 veterans and survivors. These veterans' and survivors' claims were initially filed over many years. The errors concern cases in which VA had proposed that due to disability or age the beneficiary was unable to manage his or her VA benefits without assistance, but did not complete the action by transferring it within VA for appointment of a fiduciary. VA's Veterans Benefits Administration (VBA) has set up a team to immediately review the cases, notify beneficiaries, complete the claim processing steps, and appoint a fiduciary as quickly as possible. TRICARE covers proven services and supplies needed to diagnose and treat allergies. Several types of allergic diseases or diseases worsened by allergies are: (1) hay fever; (2) asthma; (3) conjunctivitis (pink eye); (4) allergic skin conditions (hives, eczema, dermatitis); and (5) sinusitis (sinus infections). If you think you have seasonal allergies, talk to your health care provider. Your provider can provide you with tips on how to reduce or eliminate your exposure in addition to explaining the range of possible testing and treatment if recommended.
