If you want to enroll in or change your TRICARE Prime or TRICARE Select plan for 2019, you have until Dec. 10, 2018 to make an enrollment choice. If you have TRICARE For Life or a premium-based plan and want to stay in your current plan, TRICARE Open Season doesn't apply to you. You'll stay in your current plan for 2019 or as long as you're eligible.

### VA Rates 70 Percent of its Nursing Homes as Failures

In a joint release, the national commanders of the VFW and American Legion are demanding that VA Secretary Robert Wilkie bring immediate attention to his nursing home program that currently has 70 percent of its 132 homes receiving failing grades by the VA's own rating system. The call by VFW National Commander B.J. Lawrence and Legion National Commander Brett Reistad is in response to a series of scathing articles by two USA Today and Boston Globe reporters who documented substandard and negligent care at the VA nursing home in Brockton, Mass., which is one of 45 nursing homes that received the VA's lowest rating of one star. Forty-seven homes received two stars, 16 homes three stars, and 15 homes four stars. Only nine nursing homes received the VA's top five-star rating. "While much of the media's attention has been on the proper implementation of VA health care legislation, we cannot forget about 46,000 mostly senior veterans who reside in these nursing homes," said the two national commanders, who collectively speak for more than 4.6 million members and their auxiliaries. ### **GI Bill Oversight Hearing Held**

This week, the House Veterans' Affairs Subcommittee on Economic Opportunity held a hearing on the delayed payments of GI Bill benefits to student veterans. This summer, VA was supposed to implement technology upgrades to accommodate changes to the GI Bill. VA failed to implement the changes which led to tens of thousands of student veterans receiving delayed Basic Allowance for Housing payments. The VFW called on Congress to hold an oversight hearing to get to the bottom of the problem and what steps VA has taken to avoid this problem in the upcoming spring semester. Allowance Increase Announced



# Hearing on VA's Oversight of Contract Disability Examinations

The House Veterans' Affairs Subcommittee on Disability Assistance and Memorial Affairs held a hearing Thursday on VA's oversight of contract disability examinations. Over the last 20 years, VA has more frequently contracted with private health care providers to conduct disability examinations in order to provide veterans with timely, accurate, and objective evaluations of their medical conditions. While the VFW supports VA's efforts to provide veterans with contract disability examinations, since 2016 when VA executed its latest contract for disability examinations, there have been new problems which prompted the VFW and other veterans service organizations to call for a hearing to better assess the situation. The VFW submitted testimony detailing problems such as late notification of exam appointments, difficulty in rescheduling examinations, unreasonable distance of examinations from the veteran's home, and inadequate time with the health care provider. The VFW appreciates Ranking Member Esty highlighting our concerns and bringing attention to this issue. Watch the hearing.

Blue Water Navy Bill Continues to be Stalled in the Senate

In July, the House of Representatives unanimously passed H.R. 299, the Blue Water Navy Vietnam Veterans Act of 2018, to end the injustice of denying Vietnam, Korean DMZ, and Thailand veterans who suffer from life-threatening health conditions related to exposure to Agent Orange the care and benefits they deserve. This important bill continues to be stalled in the Senate and the VFW needs your help to make sure this bill is passed before the end of the year. 

First Female Completes Special Forces Assessment and Selection Course

This past week, the United States Army Special Operations Command announced that a female soldier has successfully completed the grueling 24-day Special Forces Assessment and Selection course at Ft. Bragg, N.C. The soldier, whose name was not released, will now attend the Special Forces Qualification Course (Q Course) which consists of four phases and can last from a year to two years, depending on the soldier's specialty and language training. Upon successful completion of the Q course, soldiers are awarded the green beret and assigned to a Special Forces operational detachment. Since the Department of the Army lifted its ban on women holding military occupational specialties specific to special operations and combat arms in 2016, several women have attempted to complete the course, but were unsuccessful. Despite this, hundreds of women are now serving in infantry, armor, and fire support units, to include the 75th Ranger Regiment, and more than a dozen women have earned the Ranger tab.







# This Military Spouse Scholarship Is Now Available All Year Long



VA Secretary Vows to Improve Military Transition Efforts

The VFW was at the National Press Club last week to hear VA Secretary Robert Wilkie vow to increase coordination between VA and the Department of Defense to improve the transition of military personnel to veterans status, which includes educating service members on the signs of post-traumatic stress, as well as recruiting transitioning doctors and nurses to work for VA. He does not expect the upcoming change in control of the House to impact efforts to improve services for millions of veterans receiving VA health care benefits. He said his department enjoys bipartisan support that has resulted in a record-high budget and legislation that makes possible greater accountability for VA employees and management flexibility. 'Open Season' for Federal Health Benefits Program Begins Nov. 12 marks the beginning of open season for the 2019 Federal Employees Health Benefits (FEHB) Program, Federal Flexible Spending Accounts Program (FSAFEDS), and the Federal Employees Dental and Vision Insurance Program (FEDVIP). Open season ends on Dec. 10. During the open season, employees may enroll, change health plans or options, cancel enrollment, change to Self Only, Self+1 or Self and Family and waive or begin participation in premium conversion. Also, the link for making FEHB changes is now called Government Retirement and Benefits (GRB) Platform instead of EBIS. GRB is accessed through MyPers. **TRDP and FEDVIP Update** 

The current TRICARE Retiree Dental Program (TRDP) will end Dec. 31, 2018, and will be replaced by the Federal Employees Dental and Vision Insurance Program (FEDVIP) dental coverage options. Vision plans will also be available to eligible TRICARE beneficiaries through FEDVIP. The first opportunity to enroll in FEDVIP is during the 2018 Federal Benefits Open Season, which began on Nov. 12, 2018, and runs through Dec. 10, 2018. Coverage begins on Jan. 1, 2019. In general, retired uniformed service members and their families who were eligible for TRDP in 2018 are eligible for FEDVIP dental coverage, and if enrolled in a TRICARE health plan, FEDVIP vision coverage, beginning in 2019. Family members of active-duty uniformed service members who are enrolled in a TRICARE health plan are eligible for FEDVIP vision coverage. Learn more.



### TRICARE Seeking Right Mix Of Therapies For Kids With Autism

Nearly 15,000 military children with autism receive Applied Behavioral Analysis (ABA) services to learn desired behaviors and douse undesirable behaviors under a demonstration program offered through TRICARE. Join the Air Force Hacker Challenge

The Air Force and HackerOne have teamed up for Hack the Air Force 3.0 (HtAF), the Air Force's most inclusive bug bounty program. HtAF allows computer experts to uncover vulnerabilities in Air Force websites, ultimately strengthening the service's cyber posture. This year's fourweek-long program ends Nov. 22, and will focus on DoD applications that were recently migrated to an Air Forceowned cloud environment. The program is open to 191 countries, making it the government's largest bug bounty to date. Hack the Air Force 3.0 offers competitive bounty awards dependent on the severity of the finding. Reminder: Take Advantage of Space-A Travel The Space-Available Travel program is one of the many Air Force programs available to military personnel, families, retirees and veterans with 100% disability. The program allows members to sign up for free transportation out of Dyess Air Force Base, Texas, that is not taken by the mission essential Airmen and cargo, on a base's aircraft. Passengers will need two forms of identification when checking into the terminal, which can be their Common Access Card and a driver's license. For younger children without a CAC, parents should bring a printed out Defense Enrollment Eligibility Reporting System form with the child's DOD ID number printed on it. The U.S. Air Force and the Wright Brothers Institute (WBI) are offering cash prizes for the creation of visualization tools, including Augmented Reality and Virtual Reality solutions, that will enhance Department of Defense (DoD) space operator understanding and awareness of satellites and other objects in Earth orbit. The Air Force Visionary Q-Prize Competition (VQ-Prize) runs from October 29 through January 15, 2019. No background in space applications is required. ### **Exchange Program Places Soldiers Abroad**

The Military Exchange Program places National Guard Soldiers in units from America's allied partners, including the German Army, the British Army Reserve, the Danish Home Guard and Estonian Army. In return, these nations deploy military members to participate in a host unit two-week annual training back in New York. Each general officer command in the New York Army National Guard annually nominates Soldiers to attend. Applications for the 2019 annual training season are available through December 10, 2018. # VA, Navy Announce Partnership for San Diego Healthcare

In a joint initiative to improve access to care for San Diego veterans, Naval Hospital Camp Pendleton (NHCP) and the VA San Diego Healthcare System (VASDHS) are partnering to provide total joint surgeries. Surgeons from NHCP have begun seeing patients at the VA's Oceanside clinic on a weekly basis and the first surgery is scheduled to take place at NHCP later this month. A total joint surgery is a procedure in which parts of a damaged joint are removed and replaced with a prosthesis designed to function like a healthy joint. More than 1 million such total joint procedures performed each year in the U.S. Patients referred for total joint surgery will have their initial evaluation and post-surgical care by NHCP orthopedic surgeons at the VASDHS outpatient clinic in Oceanside. The surgery will be performed at NHCP.

Exchange patrons and their families can score additional holiday savings by simply shopping with the Army & Air Force Exchange Service from Nov. 12 through 20. When military shoppers make an Exchange in-store purchase during this nine-day period, they will receive coupons to use while shopping from Nov. 16 through 20. Shoppers will save: (1) \$20 off a minimum purchase of \$100 or \$30 off when using a MILITARY STAR card; (2) \$50 off a minimum purchase of \$250 or \$60 off when using a MILITARY STAR card. ### TRICARE Emergency Procedures in Alabama, Florida

Emergency procedures are in place in Alabama and Florida due to Hurricane Michael. A list of counties affected is on the TRICARE website. To obtain an emergency refill, take your prescription bottle to any TRICARE retail network pharmacy. To find a network pharmacy, call Express Scripts at 1-877-363-1303 or search the network pharmacy locator. If possible, visit the pharmacy where the prescription was filled. If you use a retail chain, you can fill your prescription at another store in that chain. If your provider is available, he or she may call in a new prescription to any network pharmacy. You can request assistance at another pharmacy, but it is at that pharmacy's discretion to help you.



Supreme Court to Hear Case on Veterans Memorial The U.S. Supreme Court has announced that it will hear The American Legion's case regarding the Bladensburg Veterans Memorial in Prince George's County, Md. In 2015, the U.S. District Court for the District of Maryland ruled the memorial was constitutional, citing the use of crosses to mark the graves of fallen American servicemen overseas. Later, the U.S. Court of Appeals for the Fourth Circuit reversed the District Court's decision, declaring the cross shape of the memorial violates the Establishment Clause of the First Amendment to the U.S. Constitution. The American Legion is asking the Supreme Court to reverse the Court of Appeals ruling that could lead to the bulldozing of the Bladensburg Veterans Memorial. ### **VA Looks to Improve Legal Services**



# TRICARE Waives Referral Requirement in Florida

If you are evacuated, you may not have to get a referral from your primary care manager to see a TRICARE authorized provider. This is also known as a blanket referral waiver. This applies to anyone in a TRICARE Prime plan in certain counties in Florida. A list of affected counties is on the TRICARE website. This waiver is good until January 15, 2019. This includes active duty servicemembers using urgent care.
