The VA is beginning a new program for self-check-ins and appointments via your Cell Phone. Since I don't have all the details or facts on this, anyone who uses it, please do let me know the good and bad points in using this new system.

For civilian counterparts the only use of this method I know of is checking in for lab work, and LabCorp is the leader so far and it works terrific, and getting in and out of the lab quickly has improved dramatically.

The VA is now hiring Oncologists for its Teleoncology Service.

Personally, I think this is a great move on the part of the VA to have more staff in each department for this type of service and something maybe we might see in civilian life soon.

I don't know how it works or is scheduled to work, but I would hope it would be a 24/7 service. To me this would be great, especially if you're like me and often wake up in the middle of the night with questions and a place to turn to for answers.

I would like to hear from those who would be interested in seeing monthly budget reports and financial statements for each VAMC.

I've been pushing for it for a long time now as in the past years I'd read and brought to your attention the fact that many VAMC's were redirecting budgeted funds to other departments, and to departments that were for absolutely nothing, like a pandemic of an illness we've never seen in our country, etc.

To me it would be a relatively simple process to implement and could be easily uploaded to the VA Website hospital by hospital, this way we can see where problems or potential problems are or might be and can call attention to them.

I want to thank everyone who took the time to send out many if not all the pre-written E-Mails on legislation requesting their support and passage, this is one of the most important parts of our newsletter. Grabbing their attention and getting much needed Veteran legislation passed and signed into law.

But we can't let up on them, so please weekly do as much as you can! **TAKE ACTION!**

### House Starts Mark Up of Annual Defense Authorization Bill

The House Armed Services Military Personnel Subcommittee marked up and approved its portion of the FY 2023 National Defense Authorization Act (NDAA-H.R. 7900). Key provisions in the subcommittee markup include:

- No new TRICARE fee increases;
- Prohibiting reductions in military medical staff until there is an impact assessment provided to Congress;
- Providing for an annual active duty pay increase (4.6 percent) that keeps pace with civilian pay increases;
- Requiring the Secretary of Defense to complete a pay study and adjust the pay of child development center employees; and
- Numerous provisions to improve access to mental health care.

The FRA submitted a statement for the record in conjunction with the Subcommittee markup. The statement expresses opposition to increasing TRICARE fees, COLA cuts, and cuts to military medical billets. The Association urged the Subcommittee to include concurrent receipt and military divorce law (USFSPA) reform in the markup. FRA expressed concern about Navy morale issues such as the rash of suicides on the USS George Washington, the need for an annual pay increase that keeps pace with inflation, more oversight of military privatized housing, and increased funding for childcare at military installations. The Association also asked the Subcommittee to allow survivors to retain the full month's retired pay for the month in which the retiree dies, and to repeal the requirement for retirees to wait 180 days before becoming a civilian Defense Department employee.

The bill (H.R.7900) is scheduled to be marked up in the full committee (HASC) on June 22. The Senate Armed Services (SASC) Personnel Subcommittee is scheduled to markup its portion of the FY2023 NDAA on June 14 and the SASC markup will occur on June 15-16. Once approved by the full committees the bills will go to the floor of their respective chamber to consider floor amendments and be approved. After both chambers approve their version of the NDAA a conference committee will be appointed to resolve the differences between the two bills. Once the differences are resolved the final bill will be submitted to the

House and Senate for approval. If approved by both chambers the bill will be sent to the President to be signed into law or be vetoed.

### **Veterans Toxic Exposure**

As NewsBytes goes to press, the Senate is expected to approve the veteran's toxic exposure bill (H.R.3967) after the Senate voted to limit debate on the legislation (86-12). As noted in last week's NewsBytes The bill will be amended in the Senate to authorize the setup 31 major medical clinics across America and hire thousands more claims processors and health care staff.

The bill would establish a presumption of service connection for 23 respiratory illnesses and cancers related to the smoke from burn pits, used extensively in Afghanistan and Iraq to dispose of various types of waste, many of them toxic. Further, the bill also provides for new benefits for veterans who faced radiation exposure during deployments throughout the Cold War, adds hypertension and monoclonal gammopathy to the list of illnesses

linked to Agent Orange exposure in the Vietnam War, expands the timeline for Gulf War medical claims and requires new medical exams for all veterans with toxic exposure claims. Veterans who served in Thailand, Laos, Cambodia and Guam during the Vietnam War era would be covered for the first time under the same Agent Orange presumptive policies as those who served in Vietnam itself.

VA staff would be granted "the authority to determine that a veteran participated in a toxic exposure risk activity when an exposure tracking record system does not contain the appropriate data," a stark distinction from the science-only system in use at VA currently. Veteran advocates have complained that in many cases, veterans with serious illnesses obviously connected to their service have been turned away by the VA because irrefutable data showing chemical exposure during their service does not exist. The measure that passed the House is estimated to cost more than \$200 billion over 10 years and would potentially affect as many as one in five veterans living today.

Since the bill was amended in the Senate so it must go back to the House to approve the Senate amendment before being sent to the President to be signed into law.



VALife insurance program coming January 2023 for Veterans with service connection

In January 2023, VA will launch a new life insurance program called Veterans Affairs Life Insurance (VALife), which provides guaranteed acceptance whole life insurance coverage to Veterans age 80 and under, with any level of service-connected disability. Some Veterans age 81 and older may also be eligible.

**PACT ACT UPDATE** 

It looks like the Senate will quickly pass the PACT Act upon their return from recess. The bill must then return to the House to reconcile some changes made by the Senate but should quickly pass the House again and be sent to President Biden for his signature.

The PACT Act will provide for herbicide (Agent Orange) benefits for veterans serving on Guam, American Samoa, Johnston Island, and in Thailand, Laos and Cambodia. The bill will add hypertension to the list of herbicide presumptives. It will also provide coverage for radiation cleanup veterans at Eniwetok and Palomares. Finally, it will provide coverage for veterans deployed to the K-2 base in Uzbekistan and burn pit victims throughout Southwest Asia.

This bill is not all encompassing but it is a good start. It should provide toxic exposure benefits to about 3.4 million veterans.

If you have not filed a claim, file it now or at least submit an intent to file. The claim submission will mark the effective date of your benefits. Unlike the case with the Blue Water Navy, benefits will not be retroactive to previous submissions. There was a consent agreement that allowed us to make Blue Water retroactive. That is not the case with the other areas. Reserve you place in line now - file that claim.

MVA™ AT THE SUPREME COURT

What happens when a veteran suffering from Post-Traumatic Stress or Traumatic Brain Injury fails to file a claim within one year or misses an appeal date? Can this be excused? The VA says no, but if the mental illness interfered with the veteran's ability to file or pursue his claim, should he or she be denied the earlier effective date? A court case supported by Military-Veterans Advocacy® is now pending at the Supreme Court of the United States to resolve the matter. MVA<sup>TM</sup> has filed an amicus curiae brief in Arrellano v. McDonough, which argues that these deadlines are susceptible to equitable tolling. In other words, an event that was not the veteran's fault, but that prevented him from meeting these deadlines, could stop the deadline.

This case, if decided favorably, may have wide ranging ramifications. Say you wanted to file a claim for herbicide under the Blue Water Navy Act prior to the Procopio decision. A VSO refuses to accept it because of the "boots on the ground" policy. A couple of years later you convince another VSO to file the claim. If we are successful in Arrellano, we may be able to argue that the retroactive date is should be the date you first tried to file the claim, not when it was eventually filed.

Oral argument was held in this case in April. We should see a decision this month.

Senators Ask VA to Cut Red Tape for Volunteer Drivers

Senate Veterans' Affairs Committee Chairman Jon Tester (Mont.) and Committee members Maggie Hassan (N.H.) and Thom Tillis (N.C.) have dispatched a letter to Secretary Denis McDonough urging the Department of Veterans Affairs (VA) to cut red tape on its volunteer driver certification process, also known as the Volunteer Transportation Network (VTN), to assist veterans traveling to and from health care appointments.

In January 2021, the Senate passed the Johnny Isakson and David P. Roe, M.D. Veterans Health Care and Benefits Improvement Act (Public Law 116-315), which required the VA to establish a national policy regarding medical exams required to certify volunteer drivers for the VTN no later than 90 days following its passage. As of June 1, 2022, the VA has not completed this requirement.

In the letter, the senators highlighted various instances where red tape prevents VTN drivers from helping veterans access the care they need and earned. This includes drivers failing to receive a response from the VA regarding necessary paperwork to participate in the program, and prolonged wait times for physical exams required to become certified as a volunteer driver.

### For Mom's with small Children

We know the situation with being able to purchase baby formula has been a nightmare and doesn't look like it will be getting any better anytime soon.

So, I took time this week to not only call my personal physician, but several pediatricians to find what homemade formula would be the best to use as a replacement during this time of crisis.

Below is the formula I found, and presented to all doctors I spoke with (totaling 11) and each one approved this version over many others.

I do hope this helps all mom's during this time!

### **Homemade Emergency Baby Formula Recipe**

This recipe, based on World Health Organization guidelines and physician studies through the early twentieth century, is an excellent stop-gap option for when your baby is hungry and you have no other feeding options. It is meant for short-term use only.

### **Equipment**

1 quart-sized canning jar with a tight-fitting lid OR a blender Ingredients

#### FOR THE FORMULA:

- 1 13-ounce can (354 mL) full-fat evaporated milk
- 2  $\frac{1}{3}$  cups (19 fluid ounces // 562 mL) clean water, preferably slightly warm
- 2 tablespoons blackstrap molasses

#### TO GIVE SEPARATELY AS A NUTRITIONAL SUPPLEMENT:

• 1 dose multi-vitamin for infants, given daily (follow the dosage instructions on the multivitamin bottle)
Instructions

#### Instructions

**Mix the formula**. Place all ingredients in a clean, quart-sized jar with a tight-fitting lid or in a blender. Shake or blend until well-mixed. (If you're using granulated sugar, be sure to mix until it has been dissolved.)

**Feed the baby**. Pour into clean bottles and give to baby immediately or store in the refrigerator for up to three days. Discard any unused formula after three days.

**Give a multivitamin supplement**, if available. Give one dose of multivitamin to your baby at least once a day.

### How many batches of formula do I need?

1 batch will likely last you approximately 1 day, give or take a few hours.

Follow your child's hunger cues – these values are simply average guidelines.

- 0-2 months: 2-3 ounces every 2-3 hours (approximately 24 oz per day)
- 2-3 months: 4-5 ounces every 3-4 hours (approximately 32 oz per day)
- 4-5 months: 4-6 ounces every 3-4 hours (approximately 32-36 oz per day)
- 6+ months: 6-8 ounces every 4-5 times a day (approximately 32-40 oz per day)

If you have multivitamin drops, give them separately from the formula to make sure your child gets the entire dose.

### Why is there sugar in this recipe?

Sugar is used to bring the evaporated milk up closer to the level of natural sugars in human breast milk. We're calling for blackstrap molasses as the sugar because it also contains iron, sodium, and potassium.

#### What can I use instead of molasses?

If you do not have blackstrap molasses, you may substitute an equal amount of brown sugar, granulated sugar, dark corn syrup (preferably GMO-free) OR maple syrup.

DO NOT USE sweetened condensed milk, as it contains FAR too

much sugar.

**DO NOT USE HONEY** as a sugar substitute if your baby is under 12 months old.

#### **President Signs Veterans Legislation Into Law**

On Tuesday, June 7, 2022, President Biden signed nine bills into law related to veterans and the Department of Veterans Affairs (VA).

- S. 1760, which designates the community-based outpatient clinic of the Department of Veterans Affairs planned to be built in Oahu, Hawaii, as the Daniel Kahikina Akaka Department of Veterans Affairs Community-Based Outpatient Clinic;
- S. 1872, the "United States Army Rangers Veterans of World

- War II Congressional Gold Medal Act," which provides for the award of a Congressional Gold Medal to the United States Army Rangers Veterans of World War II, in recognition of their dedicated service during World War II;
- S. 2102, the "Dr. Kate Hendricks Thomas Supporting Expanded Review for Veterans In Combat Environments Act" or the "Dr. Kate Hendricks Thomas SERVICE Act," which expand eligibility for VA mammography screening to veterans who served in locations associated with toxic exposures;
- S. 2514, which renames the Provo Veterans Center in Orem, Utah, as the Col. Gail S. Halvorsen "Candy Bomber" Veterans Center:
- S. 2533, the "Making Advances in Mammography and Medical Options for Veterans Act," which makes a number of changes to VA's mammography screening and access to related medical care;
- S. 2687, the "Strengthening Oversight for Veterans Act of 2021," which temporarily authorizes the Department of Veterans Affairs' Office of Inspector General to issue subpoenas in certain circumstances;
- S. 3527, which authorizes VA to transfer to another property the name of a VA property that was named in statute;
- S. 4089, the "Veterans Rapid Retraining Assistance Program Restoration and Recovery Act of 2022," which restores entitlement to educational assistance under the Veterans Rapid Retraining Program under certain conditions; Thank you to Senator Durbin and Representatives Danny Davis and Underwood for their leadership; and
- S. 4119, the "RECA Extension Act of 2022," which extends by two years the availability of compensation for radiation exposure related to nuclear weapons development.
